1 A BILL ~~for an Act to amend and reenact sections 15.1-21-02.4, 15.1-21-02.5, and 15.1-21-02.6~~  
2 ~~of the North Dakota Century Code, relating to the provision of North Dakota scholarships to~~  
3 ~~students who receive home education.~~ for an Act to create and enact two new sections to  
4 chapter 15.1-21 of the North Dakota Century Code, relating to the provision of North Dakota  
5 scholarships to students who receive home education; and to amend and reenact section  
6 15.1-21-02.6 of the North Dakota Century Code, relating to the provision of North Dakota  
7 scholarships to students who receive home education.

8 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

9 ~~— **SECTION 1. AMENDMENT.** Section 15.1-21-02.4 of the North Dakota Century Code is~~  
10 ~~amended and reenacted as follows:~~

11 ~~— **15.1-21-02.4. North Dakota career and technical education scholarship.**~~

12 ~~— Any resident student who graduates from a high school or completes a program of home~~  
13 ~~education supervised in accordance with chapter 15.1-23, during or after the 2010-11 school~~  
14 ~~year, is eligible to receive a North Dakota career and technical education scholarship provided~~  
15 ~~the student:~~

16 ~~— 1. Completed four units of English language arts from a sequence that includes literature,~~

9 ~~Any resident student who graduates from a high school or completes a program of home~~  
10 ~~education supervised in accordance with chapter 15.1-23, during or after the 2010-11 school~~  
11 ~~year, is eligible to receive a North Dakota academic scholarship provided the student:~~

12 ~~1. Completed four units of English language arts from a sequence that includes literature,~~  
13 ~~composition, and speech;~~

14 ~~2. Completed three units of mathematics, including:~~

15 ~~a. One unit of algebra II, as defined by the superintendent of public instruction; and~~

16 ~~b. One unit of mathematics for which algebra II, as defined by the superintendent of~~  
17 ~~public instruction, is a prerequisite;~~

18 ~~3. Completed three units of science, including:~~

19 ~~a. One unit of physical science;~~

20 ~~b. One unit of biology; and~~

21 ~~c. (1) One unit of any other science; or~~

1 ~~b. A scholarship under this section is available to any eligible resident student who~~  
2 ~~completes the requirements of subsections 1 through 9 of section 15.1-21-02.4 or~~  
3 ~~subsections 1 through 10 of section 15.1-21-02.5, through a program of home~~  
4 ~~education supervised in accordance with chapter 15.1-23.~~

5 ~~7. For purposes of North Dakota scholarship eligibility under this section, "full-time"~~  
6 ~~means enrollment in at least twelve credits during a student's first two semesters and~~  
7 ~~enrollment in at least fifteen credits during each semester thereafter or enrollment in~~  
8 ~~the equivalent number of credits, as determined by the state board of higher~~  
9 ~~education, with respect to students in a quarter system.~~

10 **SECTION 1.** A new section to chapter 15.1-21 of the North Dakota Century Code is created  
11 and enacted as follows:

12 **North Dakota career and technical education scholarship - Home-educated students.**

13 Any resident student who completes a program of home education supervised in  
14 accordance with chapter 15.1-23, during or after the 2013-14 school year, is eligible to receive a  
15 North Dakota career and technical education scholarship provided the student:

16 1. Completed all units required by subsections 1 through 7 of section 15.1-21-02.4; and

17 2. Received:

18 a. A composite score of at least twenty-four on an ACT; or

19 b. A score of at least five on each of three WorkKeys assessments recommended  
20 by the department of career and technical education and approved by the  
21 superintendent of public instruction.

22 **SECTION 2.** A new section to chapter 15.1-21 of the North Dakota Century Code is created  
23 and enacted as follows:

24 **North Dakota academic scholarship - Home-educated students.**

25 Any resident student who completes a program of home education supervised in  
26 accordance with chapter 15.1-23, during or after the 2013-14 school year, is eligible to receive a  
27 North Dakota academic scholarship provided the student:

28 1. Completed all units required by subsections 1 through 7 of section 15.1-21-02.5;

29 2. Received a composite score of at least twenty-four on an ACT; and

30 3. a. Fulfilled any one unit requirement set forth in subsections 1 through 7 of section  
31 15.1-21-02.5 by means of an advanced placement course and examination; or

1 b. Fulfilled any one-half unit requirement set forth in subsections 1 through 7 of  
2 section 15.1-21-02.5 by means of a dual-credit course.

3 **SECTION 3. AMENDMENT.** Section 15.1-21-02.6 of the North Dakota Century Code is  
4 amended and reenacted as follows:

5 **15.1-21-02.6. North Dakota scholarship - Amount - Applicability.**

- 6 1. a. The state board of higher education shall provide to any student certified as  
7 being eligible by the superintendent of public instruction either a North Dakota  
8 academic scholarship or a North Dakota career and technical education  
9 scholarship in the amount of seven hundred fifty dollars for each semester during  
10 which the student is enrolled full time at an accredited institution of higher  
11 education in this state and maintains a cumulative grade point average of 2.75.
- 12 b. The state board of higher education shall provide to any student certified as  
13 being eligible by the superintendent of public instruction either a North Dakota  
14 academic scholarship or a North Dakota career and technical education  
15 scholarship in the amount of five hundred dollars for each quarter during which  
16 the student is enrolled full time at an accredited institution of higher education in  
17 this state and maintains a cumulative grade point average of 2.75.
- 18 2. The state board shall monitor each scholarship recipient to ensure that the student  
19 meets the academic and other requirements of this section. Upon determining that a  
20 recipient student has failed to meet the requirements of this section, the board shall  
21 provide notification to the student within ten days.
- 22 3. A student is not entitled to receive more than six thousand dollars under this section.
- 23 4. The state board of higher education shall forward the scholarship directly to the  
24 institution in which the student is enrolled.

7                    ~~b.~~ (2) A high school in a bordering state under chapter 15.1-29; or

8                    ~~c.~~ (3) A nonpublic high school in a bordering state while residing with a custodial  
9                    parent in this state.

10                   b. A scholarship under this section is available to any eligible student who  
11                   completes the requirements of section 1 or 2 of this Act through a program of  
12                   home education supervised in accordance with chapter 15.1-23.

13                   7. For purposes of North Dakota scholarship eligibility under this section, "full-time"  
14                   means enrollment in at least twelve credits during a student's first two semesters and  
15                   enrollment in at least fifteen credits during each semester thereafter or enrollment in  
16                   the equivalent number of credits, as determined by the state board of higher  
17                   education, with respect to students in a quarter system.
