3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 53-06.1-12 of the North Dakota Century Code is

5 amended and reenacted as follows:

6 53-06.1-12. Gaming tax - Deposits and allocations.

- 7 A gaming tax is imposed on the total gross proceeds received by a licensed 1. 8 organization in a guarter and it must be computed and paid to the attorney general on 9 a guarterly basis on the tax return. This tax must be paid from adjusted gross 10 proceeds and is not part of the allowable expenses. The tax rate for For a licensed 11 organization with gross proceeds: 12
 - Not exceeding five hundred thousand dollars is one percent of gross proceeds. а.
 - Exceeding five hundred thousand dollars but not exceeding one million five b. hundred thousand dollars the tax is one and one-half percent of gross proceeds.
- 15 Exceeding one million five hundred thousand dollars but not exceeding one-c.<u>b.</u> 16 million five hundred the tax is fifteen thousand dollars is plus two and twenty-five 17 hundredths percent of gross proceeds exceeding one million five hundred 18 thousand dollars.
 - Exceeding one million five hundred thousand dollars is two and one-halfis one-d. percent of gross proceeds.
- 21 2. The tax must be paid to the attorney general at the time tax returns are filed.
- 22 3. Except as provided in subsection 4, the attorney general shall deposit gaming and 23 excise taxes, monetary fines, and interest and penalties collected in the general fund 24 in the state treasury.

1	4.	The attorney general shall deposit sixnine and two-tenthsseven percent of the total
2		taxes, less refunds, collected under this section into a gaming and excise tax
3		allocation fund. Pursuant to legislative appropriation, moneys in the fund must be
4		distributed quarterly to cities and counties in proportion to the taxes collected under
5		this section from licensed organizations conducting games within each city, for sites
6		within city limits, or within each county, for sites outside city limits. If a city or county
7		allocation under this subsection is less than two hundred dollars, that city or county is
8		not entitled to receive a payment for the quarter and the undistributed amount must be
9		included in the total amount to be distributed to other cities and counties for the
10		quarter.
