- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the public service
- 2 commission; to amend and reenact section 49-01-05 of the North Dakota Century Code,
- 3 relating to the salary of public service commissioners; to provide for a legislative management
- 4 study; to authorize a transfer; and to declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the public service commission for the purpose of defraying the expenses of the public service commission, for the biennium beginning July 1, 2013, and ending June 30, 2015, as follows:

- SECTION 3. AMENDMENT. Section 49-01-05 of the North Dakota Century Code is amended and reenacted as follows:

49-01-05. Salary of commissioners.

The annual salary of a commissioner is ninety-twoninety-eight thousand eightfour hundred twenty-sixseventy-nine dollars through June 30, 20122014, and ninety-fiveone hundred one thousand sixfour hundred eleventhirty-three dollars thereafter. All fees received or charged by any commissioner for any act or service rendered in any official capacity must be accounted for and paid over by the commissioner monthly to the state treasurer and must be credited to the general fund of the state.

SECTION 4. LEGISLATIVE MANAGEMENT STUDY. The legislative management shall consider studying during the 2013-14 interim civil penalties assessed and collected by state agencies, including a review of the funds into which the collections are deposited and the appropriateness of the use of funds collected. The legislative management shall report its findings and recommendations, together with any legislation required to implement the recommendations, to the sixty-fourth legislative assembly.

SECTION 5. INFORMATION TECHNOLOGY HARDWARE - TRANSFER TO SECURE

DATA CENTER. The public service commission shall transfer all appropriate information

TRANSFER AND REPAYMENT - BEGINNING FARMER REVOLVING LOAN 4 **FUND.** The sum of \$900,000, or so much of the sum as may be necessary, included in the 5 estimated income line item in section 1 of this Act, shall be transferred by the Bank of North 6 Dakota from the beginning farmer revolving loan fund to the public service commission to pay 7 for costs associated with a rail rate complaint case. Transfers shall be made during the 8 biennium beginning July 1, 2013, and ending June 30, 2015, upon order of the commission. If 9 any amounts are spent pursuant to this section, the public service commission shall reimburse 10 the beginning farmer revolving loan fund using amounts available from damages or proceeds 11 received, net of legal fees, from a successful outcome of a rail complaint case. 12 SECTION 7. LEGISLATIVE INTENT - GAS PIPELINE SAFETY INSPECTOR.
