1 A BILL for an Act to amend and reenact sections 15.1-21-02.4 and 15.1-21-02.5 of the North  
2 Dakota Century Code, relating to eligibility for North Dakota career and technical scholarships  
3 and North Dakota academic scholarships.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 15.1-21-02.4 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **15.1-21-02.4. North Dakota career and technical education scholarship.**

8 Any resident student who graduates from a high school during or after the 2010-11 school  
9 year is eligible to receive a North Dakota career and technical education scholarship provided  
10 the student:

- 11 1. Completed four units of English language arts from a sequence that includes literature,  
12 composition, and speech;
- 13 2. Completed three units of mathematics, including:
  - 14 a. One unit of algebra II, as defined by the superintendent of public instruction; and
  - 15 b. Two units of any other mathematics;
- 16 3. Completed three units of science, including:
  - 17 a. One unit of physical science;
  - 18 b. One unit of biology; and
  - 19 c. (1) One unit of any other science; or
  - 20 (2) Two one-half units of any other science;
- 21 4. Completed three units of social studies, including:
  - 22 a. One unit of United States history;

- 1           b. (1) One-half unit of United States government and one-half unit of economics;

3           (2) One unit of problems of democracy; and  
4           c. One unit or two one-half units of any other social studies, which may include  
5           civics, civilization, geography and history, multicultural studies, North Dakota  
6           studies, psychology, sociology, and world history;  
7           5. a. Completed one unit of physical education; or  
8           b. One-half unit of physical education and one-half unit of health;  
9           6. Completed:  
10           a. One unit selected from:  
11                   (1) Foreign languages;  
12                   (2) Native American languages;  
13                   (3) American sign language;  
14                   (4) Fine arts; or  
15                   (5) Career and technical education courses; and  
16           b. Two units of a coordinated plan of study recommended by the department of

9 d. Obtained a score of at least five on each of three WorkKeys assessments  
10 recommended by the department of career and technical education and  
11 approved by the superintendent of public instruction.

12 **SECTION 2. AMENDMENT.** Section 15.1-21-02.5 of the North Dakota Century Code is  
13 amended and reenacted as follows:

14 **15.1-21-02.5. North Dakota academic scholarship.**

15 Any resident student who graduates from a high school during or after the 2010-11 school  
16 year is eligible to receive a North Dakota academic scholarship provided the student:

- 17 1. Completed four units of English language arts from a sequence that includes literature,  
18 composition, and speech;
- 19 2. Completed three units of mathematics, including:
  - 20 a. One unit of algebra II, as defined by the superintendent of public instruction; and
  - 21 b. One unit of mathematics for which algebra II, as defined by the superintendent of  
22 public instruction, is a prerequisite;
- 23 3. Completed three units of science, including:
  - 24 a. One unit of physical science;
  - 25 b. One unit of biology; and
  - 26 c. (1) One unit of any other science; or  
27 (2) Two one-half units of any other science;
- 28 4. Completed three units of social studies, including:
  - 29 a. One unit of United States history;
  - 30 b. (1) One-half unit of United States government and one-half unit of economics;

- 1 (2) One unit of problems of democracy; and
- 2 c. One unit or two one-half units of any other social studies, which may include
- 3 civics, civilization, geography and history, multicultural studies, North Dakota

- 6 b. One-half unit of physical education and one-half unit of health;
