- 1 A BILL for an Act to create and enact a new section to chapter 20.1-02 of the North Dakota
- 2 Century Code, relating to depredation kill permits for geese; and to amend and reenact section
- 3 20.1-03-07.1 of the North Dakota Century Code, relating to the early September Canada goose
- 4 season.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. A new section to chapter 20.1-02 of the North Dakota Century Code is created
7 and enacted as follows:

## 8 Manner for use of goose depredation kill permits.

9 <u>The director may not take any punitive or remedial action against an individual using a rifle</u>

10 to take a goose with a depredation kill permit issued by the department.

11 SECTION 2. AMENDMENT. Section 20.1-03-07.1 of the North Dakota Century Code is

12 amended and reenacted as follows:

## 20.1-03-07.1. (Effective through July 31, 2013) Nonresident waterfowl hunting license required.

15 Except as provided in sections 20.1-02-05, 20.1-03-07.2, and 20.1-03-07.3, a nonresident 16 may not hunt waterfowl unless that individual first obtains a nonresident waterfowl hunting 17 license. However, a nonresident may hunt cranes after first obtaining a nonresident waterfowl 18 hunting license or a nonresident small game hunting license. Except as otherwise provided in 19 this section, the nonresident waterfowl hunting license entitles the nonresident to hunt waterfowl 20 for any period of fourteen consecutive days or any two periods of seven consecutive days each. 21 A license authorizing the fourteen-day hunting period allows hunting in a specified waterfowl 22 hunting zone. A license authorizing two 7-day hunting periods allows hunting in a specified zone 23 during each period. Upon payment of the fee for a statewide nonresident waterfowl hunting 24 license, a nonresident may hunt waterfowl in any zone. Forty dollars of the fee for a statewide

1 nonresident waterfowl license must be used for the private land open to sportsmen program. 2 The governor, in the governor's proclamation, shall specify various waterfowl hunting zones for 3 which nonresident waterfowl hunting licenses will be available, and may specify the number of 4 licenses which may be issued in each zone and the manner in which they are to be issued. A 5 nonresident is entitled to purchase only one nonresident waterfowl hunting license per year. The 6 fourteen-day and two 7-day hunting period restrictions do not apply to nonresidents hunting in-7 Richland and Sargent Counties or in Benson, Ramsey, or Towner Counties during the early 8 September Canada goose season. 9 (Effective after July 31, 2013) Nonresident waterfowl hunting license required. 10 Except as provided in sections 20.1-02-05, 20.1-03-07.2, and 20.1-03-07.3, a nonresident 11 may not hunt waterfowl unless that individual first obtains a nonresident waterfowl hunting-12 license. However, a nonresident may hunt cranes after first obtaining a nonresident waterfowl-13 hunting license or a nonresident small game hunting license. A 24 nonresident is entitled to purchase only one nonresident waterfowl hunting license per year.
