10 **SECTION 1. AMENDMENT.** Subsection 2 of section 15-10-19.1 of the North Dakota

5 (3) A benefited employee of the North Dakota university system;

6 f.h. A person who was a legal resident of this state for at least three consecutive
7 years within six years of the beginning of the academic term; or

8 g.i. A child, widow, or widower of a veteran as defined in section 37-01-40 who was
9 killed in action or died from wounds or other service-connected causes, was
10 totally disabled as a result of service-connected causes, died from
11 service-connected disabilities, was a prisoner of war, or was declared missing in
12 action.
