## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. APPROPRIATION.** The funds are provided in this section, or so much of the 5 funds as may be necessary, are appropriated out of any moneys in the general fund in the state 6 treasury, not otherwise appropriated, and from special funds derived from federal funds and 7 other income, to the North Dakota aeronautics commission for the purpose of defraying the 8 expenses of the North Dakota aeronautics commission, for the biennium beginning July 1,

9 2013, and ending June 30, 2015, as follows:
