1 A BILL for an Act to amend and reenact sections 12-63-09 and 12-63-12 of the North Dakota
2 Century Code, relating to peace officer licenses; and to repeal section 12-63-08 of the North
3 Dakota Century Code, relating to peace officer licenses.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 12-63-09 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **12-63-09. Limited license.**

- 8 1. ~~Pending successful completion of the written examination required in this chapter,~~
9 ~~the~~The board may grant a limited license to a person an individual who has completed
10 the education, medical, and psychological examination requirements, criminal history
11 background investigation, and has been qualified to carry a sidearm requirements of
12 the board and this chapter.
- 13 2. The limited license allows the ~~person~~individual to ~~practice~~perform peace officer duties
14 in accordance with the rules of the board. ~~Except as otherwise provided, the limited~~
15 ~~license is valid for no longer than the earlier of the expiration of the next available~~
16 ~~training session, until the person is issued a license under section 12-63-10, or until~~
17 ~~the limited license is suspended or revoked by the board.~~
- 18 3. ~~After being~~becoming employed ~~but before taking the written examination as a peace~~
19 ~~officer, the person~~individual shall attend the first available basic full-time peace officer
20 training program recognized course authorized by the board. ~~The limited license may~~
21 ~~be renewed one time if the person has failed the examination. On terms and~~
22 ~~conditions prescribed by the board, the~~ in accordance with the rules of the board.
- 23 4. The limited license is limited to the jurisdiction in which the person is employed and is
24 valid until:

- 1 a. The individual has completed the first available basic full-time peace officer
- 2 training course authorized by the board; and
- 3 b. The individual has completed the licensing examination and has been issued a
- 4 peace officer license by the board.
- 5 5. The limited license may be renewed one time if the individual has failed the licensing
- 6 examination.
- 7 6. The limited license is subject to section 12-63-12.

8 **SECTION 2. AMENDMENT.** Section 12-63-12 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **12-63-12. Adverse license action - Appeal.**

- 11 1. The board may deny a license, refuse to renew a license, suspend a license, or
- 12 revoke a license, or may impose probationary conditions if the ~~person~~individual:
- 13 a. Has been convicted or pled guilty or nolo contendere before a court of competent
- 14 jurisdiction in any state, or before any court, of ~~an~~ a felony offense, an offense
- 15 involving domestic violence or violation of a domestic violence restraining order,
- 16 an offense involving child abuse or neglect, an offense involving firearms, or any
- 17 offense determined by the board to have a direct bearing upon ~~a person's~~an
- 18 individual's ability to serve as a peace officer, or the board determines, following
- 19 a conviction or adjudication, that the ~~person~~individual is not rehabilitated under
- 20 section 12.1-33-02.1.
- 21 b. Has used unjustified deadly force in the performance of the duties as a peace
- 22 officer as described in section 12.1-05-07.
- 23 c. Has made a false material statement under oath to the board.
- 24 d. Has made a false material statement to the board while obtaining or renewing a
- 25 license or permit.
- 26 e. Has violated a provision of this chapter or a rule of the board.
- 27 2. Denial, refusal to renew, suspension, revocation, or imposition of probationary
- 28 condition on a license may be ordered by the board after a hearing in ~~a manner~~
- 29 ~~provided by rules adopted by the board~~accordance with chapter 28-32. An application
- 30 for reinstatement may be made to the board one year from the date of the refusal to
- 31 renew or the revocation of the license. The board may accept or reject an application

1 for reinstatement and may hold a hearing to consider the reinstatement. In the case of
2 a denial of an application, the applicant may not reapply for a period of one year from
3 the date of the order of denial.

4 3. An appeal from the final decision of the board to refuse to issue, to not renew, to
5 suspend, or to revoke a license may be made to the district court. Venue is the county
6 in which the aggrieved ~~person~~individual resides. The appeal must be made within
7 ~~ninety~~thirty days from the service of the decision on the ~~person~~individual.

8 **SECTION 3. REPEAL.** Section 12-63-08 of the North Dakota Century Code is repealed.
