Engrossed HB 1240 provides a sales tax exemption for charitable nonprofit organizations and posts/organizations of past and present members of the US Armed Forces.

If enacted, engrossed HB 1240 is expected to reduce state general fund and state aid distribution fund revenues by an estimated \$19.66 million, for the 18 months in the 2013-15 biennium for which it would be in effect. This fiscal impact is for the non-profit charitable organizations only. The engrossed bill expands the exemption for sales made to certain military organizations - such as the VFW Associations and American Legion Posts. We cannot estimate the additional state general fund and state aid distribution fund revenue reduction that would result from this expanded sales tax exemption.
