10 administration and implementation of licensing and reciprocity standards for licensees.

11 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

12 ~~—~~ **SECTION 1.** ~~Subsection 6 to section 23-01-03 of the North Dakota Century Code is created~~
13 ~~and enacted as follows:~~

14 ~~—~~ 6. Develop a plan, during the 2015-16 interim, for the administration and implementation
15 of uniform licensing and reciprocity standards for licensees of the board of addiction
16 counseling examiners, board of counselor examiners, North Dakota board of social
17 work examiners, state board of psychologist examiners, state board of medical
18 examiners, and North Dakota marriage and family therapy licensure board. The plan
19 must include a standard for issuance of licenses to qualified applicants within 30 days
20 of application. The health council shall evaluate whether regional, national, and
21 international licensing and reciprocity standards are adequate for licensure in the
22 state. Before July 1, 2016, the health council shall present its findings, the proposed
23 plan, and any legislative changes necessary to implement that plan, to an interim
24 committee designated by the legislative management.

4 **SECTION 1. BEHAVIORAL HEALTH LICENSURE BOARDS - PLAN FOR**
5 **ADMINISTRATION AND IMPLEMENTATION OF LICENSING AND RECIPROCITY**
6 **STANDARDS FOR LICENSEES - REPORT TO LEGISLATIVE MANAGEMENT.**

- 7 1. During the 2015-16 interim, the board of addiction counseling examiners, board of
8 counselor examiners, North Dakota board of social work examiners, state board of
9 psychologist examiners, state board of medical examiners, and North Dakota marriage
10 and family therapy licensure board, shall, in collaboration with the other boards,
11 develop a plan for the administration and implementation of licensing and reciprocity
12 standards for licensees. The plan must include a standard for issuance of licenses to
13 qualified applicants in a timely manner. The boards shall evaluate whether regional,
14 national, or international licensing and reciprocity standards are adequate for licensure
15 in the state.
- 16 2. Before July 1, 2016, each board shall present its findings, the proposed plan, and any
17 legislative changes necessary to implement the plan, to the legislative management.
