ENGROSSED SENATE BILL NO. 2166

1 A BILL for an Act to create and enact paragraph 40 to subdivision a of subsection 3 of section
 2 39-06.1-10 of the North Dakota Century Code, relating to entries against driving records; to
 3 amend and reenact ~~section~~ sections 39-06.1-05 and 39-06.1-09, subdivision b of subsection 3
 4 of section 39-06.1-10, and sections 39-07-09 and 39-21-45.1 of the North Dakota Century
 5 Code, relating to authorized procedures for traffic violations, definitions of moving violations,
 6 entries against driving records, discretion for release upon promise to appear, and modified
 7 vehicles.

8 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

9 **SECTION 1. AMENDMENT.** Section 39-06.1-05 of the North Dakota Century Code is
 10 amended and reenacted as follows:

11 **39-06.1-05. Offenses excepted.**

12 The procedures authorized under sections 39-06.1-02 and 39-06.1-03 may not be utilized
 13 by a person charged with one of the following offenses:

- 14 1. Driving or being in actual physical control of a vehicle in violation of section 39-08-01,
 15 or an equivalent ordinance.
- 16 2. Reckless driving or aggravated reckless driving in violation of section 39-08-03, or an
 17 equivalent ordinance.
- 18 3. A violation of chapter 12.1-16 resulting from the operation of a motor vehicle.
- 19 4. Leaving the scene of an accident in violation of section 39-08-04, 39-08-05, 39-08-07,
 20 or 39-08-08, or equivalent ordinances.
- 21 5. Driving while license or driving privilege is suspended or revoked in violation of section
 22 39-06-42, or an equivalent ordinance.
- 23 6. Violating subdivision b or c of subsection 5 of section 39-24-09.
- 24 7. ~~Operating a modified motor vehicle in violation of section 39-21-45.1.~~

- 1 ~~8.~~ Operating an unsafe vehicle in violation of subsection 2 of section 39-21-46.
- 2 9.8. Causing an accident with an authorized emergency vehicle or a vehicle operated by or
- 3 under the control of the director used for maintaining the state highway system in
- 4 violation of subsection 5 of section 39-10-26.

5 **SECTION 2. AMENDMENT.** Section 39-06.1-09 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **39-06.1-09. Moving violation defined.**

8 For the purposes of sections 39-06.1-06 and 39-06.1-13, a "moving violation" means a
9 violation of section 39-04-22, subsection 1 of section 39-04-37, section 39-04-55, 39-06-01,
10 39-06-14, 39-06-14.1, 39-06-16, 39-08-20, 39-08-23, 39-08-24, 39-09-01, 39-09-01.1,
11 39-09-04.1, or 39-09-09, subsection 1 of section 39-12-02, section 39-12-04, 39-12-05,
12 39-12-06, 39-12-09, 39-21-45.1, 39-24-02, or 39-24-09, except subdivisions b and c of
13 subsection 5 of section 39-24-09, or equivalent ordinances; or a violation of the provisions of
14 chapter 39-10, 39-10.2, or 39-21, or equivalent ordinances, except subsection 5 of section
15 39-10-26, ~~sections~~section 39-21-44, and ~~39-21-45.1~~, subsections 2 and 3 of section 39-21-46,
16 and those sections within those chapters which are specifically listed in subsection 1 of section
17 39-06.1-08.

18 **SECTION 3.** Paragraph 40 of subdivision a of subsection 3 of section 39-06.1-10 of the
19 North Dakota Century Code is created and enacted as follows:

20 (40) Driving a modified motor vehicle in violation of section 1 point
21 39-21-45.1, or equivalent ordinance

22 **SECTION 4. AMENDMENT.** Subdivision b of subsection 3 of section 39-06.1-10 of the
23 North Dakota Century Code is amended and reenacted as follows:

SECTION 5. AMENDMENT. Section 39-07-09 of the North Dakota Century Code is amended and reenacted as follows:

39-07-09. Offenses under which person halted may not be entitled to release upon promise to appear.

Section 39-07-07 does not apply to a person if:

- 1 1. The halting officer has good reason to believe the person guilty of any felony or if the
- 2 person is halted and charged with an offense listed in section 39-06.1-05 but not listed
- 3 in subsection 2; or
- 4 2. The halting officer, acting within the officer's discretion, determines that it is
- 5 inadvisable to release the person upon a promise to appear and if the person has
- 6 been halted and charged with any of the following offenses:
- 7 a. Reckless driving.
- 8 b. Driving in excess of speed limitations established by the state or by local
- 9 authorities in their respective jurisdictions.
- 10 c. Driving while license or driving privilege is suspended or revoked for violation of
- 11 section 39-06-42, or an equivalent ordinance.
- 12 d. ~~Operating a modified vehicle.~~
- 13 e. Driving without liability insurance in violation of section 39-08-20.
- 14 f.e. Failing to display a placard or flag, in violation of any rule implementing section
- 15 39-21-44, while transporting explosive or hazardous materials.
- 16 g.f. Operating an unsafe vehicle in violation of subsection 2 of section 39-21-46.

17 The halting officer forthwith shall take any person not released upon a promise to appear before
18 the nearest or most accessible magistrate.

19 **SECTION 6. AMENDMENT.** Section 39-21-45.1 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **39-21-45.1. Modification of motor vehicle.**

- 22 1. Except as otherwise provided in this section, ~~a person~~ an individual may not operate
23 upon a public highway a motor vehicle of a type required to be registered under the
24 laws of this state with a weight of ~~seventen~~ thousand pounds [~~3175.144535.92-~~
25 kilograms] or less with alterations or changes from the manufacturer's original design
26 of the suspension, steering, or braking system of the motor vehicle. The weight must
27 be computed on the basis of the unmodified and unloaded weight of the motor vehicle
28 and without regard to any ballast that may be placed in the vehicle.
- 29 2. As to bumpers, motor vehicle height, and permitted modifications, the following
30 requirements also apply:
 - 31 4. a. The motor vehicle must be equipped with front and rear bumpers.
