5 SECTION 1. Section 54-06-14.5 of the North Dakota Century Code is created and enacted

54-06-14.5. Sick leave for consequences of domestic violence, a sex offense, stalking or terrorizing.

- 12 <u>b.</u> <u>"Sex offense" means an offense under chapter 12.1-20.</u>
- 13 <u>c.</u> <u>"Stalking" means an offense under section 12.1-17-07.1.</u>
- 14 <u>d.</u> <u>"Terrorizing" means an offense under section 12.1-07-14.</u>
- 15 <u>2.</u> <u>Under section 54-06-14, an employer shall grant an employee's request to use sick</u>
 16 leave to:
- 17a.Seek legal or law enforcement assistance or remedies to ensure the health and18safety of the employee or employee's family members, including preparing for or19participating in any civil or criminal legal proceeding related to or derived from20domestic violence, a sex offense, stalking, or terrorizing;
- 21b.Seek treatment by a health care provider for physical or mental injuries caused22by domestic violence, a sex offense, stalking, or terrorizing, or to attend to health
