1 A BILL ~~for an Act to create and enact a new section to chapter 24-02 of the North Dakota~~
2 ~~Century Code, relating to parking on the capitol grounds for employees with infants.~~for an Act to
3 amend and reenact section 54-21-18 of the North Dakota Century Code, relating to parking on
4 the capitol grounds for employees with infants.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 ~~SECTION 1. A new section to chapter 24-02 of the North Dakota Century Code is created~~
7 ~~and enacted as follows:~~
8 ~~Parking on capitol grounds for employees with infants.~~
9 ~~If an individual is allowed by a state agency housed on the capitol grounds to bring an infant~~
10 ~~to work, the highway patrol shall provide the individual a temporary permit or use some other~~
11 ~~means that allows the individual to park in any parking area in which a member of the public is~~
12 ~~allowed to park, not including parking for the mobility impaired, emergency or fire zones, or~~
13 ~~zones for which another permit is required, on the capitol grounds for the time the individual is~~
14 ~~allowed to bring an infant to work.~~

15 **SECTION 1. AMENDMENT.** Section 54-21-18 of the North Dakota Century Code is
16 amended and reenacted as follows:
17 **54-21-18. ~~Custody of office building -- Considered~~Office building part of capitol**
18 **building - Director ~~has control of public property~~capitol grounds - Parking for employees**
19 **~~with infants~~ - Rules - Penalty.**
20 1. The director of the office of management and budget shall control, manage, and
21 maintain the state office building. The building must be considered a part of the state
22 capitol building within the meaning of statutes relating to the custody, maintenance,
23 and control of the state capitol building and grounds, and within the meaning of

1 statutes requiring state departments or agencies to maintain their offices in the state
2 capitol building.

3 2. Except as otherwise provided by law, the director of the office of management and
4 budget has charge and control of the executive mansion, the capitol, and the park and
5 public grounds connected therewith. Except as provided by sections 39-10-48,
6 39-10-50, 44-08-18, and 54-21-17.1, the director may adopt rules to promote the
7 health, safety, and general welfare, to prohibit disturbances and disorderly assemblies,
8 to keep the peace, and to regulate nuisances on the capitol grounds and in any of the
9 buildings located on the capitol grounds. The rules may include regulation of public
10 assemblies and accessibility to the buildings and grounds, obstructions, fees,
11 insurance, forms, indemnification by users, and waiver of insurance and indemnity
12 requirements by the director. A person who violates a rule adopted by the director
13 under this section is guilty of an infraction.

14 3. If an individual is allowed by a state agency housed on the capitol grounds to bring an
15 infant to work, the office of management and budget shall provide the individual a
16 temporary permit or use some other means that allow the individual to park in any
17 parking area in which a member of the public is allowed to park, not including parking
18 for the mobility impaired, emergency or fire zones, or zones for which another permit is
19 required, on the capitol grounds for the time the individual is allowed to bring an infant
20 to work.
