

**FIRST ENGROSSMENT
with Conference Committee Amendments
ENGROSSED HOUSE BILL NO. 1009**

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state fair
2 association; to create and enact a new section to chapter 4-02.1 of the North Dakota Century
3 Code, relating to repair and maintenance of asphalt areas on the state fairgrounds; to provide
4 legislative intent; and to provide for a legislative management study; and to declare an
5 emergency.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
8 as may be necessary, are appropriated out of any moneys in the general fund in the state
9 treasury, not otherwise appropriated, to the state fair association for the purpose of defraying
10 the expenses of the state fair association, for the biennium beginning July 1, 2015, and ending
11 June 30, 2017, as follows:

17 SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO

18 **SIXTY-FIFTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding
19 items approved by the sixty-third legislative assembly for the 2013-15 biennium and the
20 2015-17 one-time funding items included in the appropriation in section 1 of this Act:

1 The 2015-17 one-time funding amounts are not part of the entity's base budget for the 2017-19
2 biennium. The state fair association shall report to the appropriations committees of the
3 sixty-fifth legislative assembly on the use of the one-time funding for the biennium beginning
4 July 1, 2015, and ending June 30, 2017.

5 **SECTION 3.** A new section to chapter 4-02.1 of the North Dakota Century Code is created
6 and enacted as follows:

7 **Repair and maintenance of asphalt area.**

8 The state fair association shall pay for the cost of any general repair or maintenance of the
9 asphalt area on the state fairgrounds from revenue sources other than the state general fund.

10 **SECTION 4. LEGISLATIVE INTENT - 2011 FLOOD EVENT.** It is the intent of the
11 sixty-fourth legislative assembly that the \$1,000,000 from the general fund appropriated in
12 section 1 of this Act is the final appropriation of funds to defray expenses to the state fair
13 relating to damages caused to asphalt by the 2011 flood event.

14 **SECTION 5. LEGISLATIVE MANAGEMENT STUDY - MAINTENANCE AND REPAIR OF**
15 **STATE PROPERTY.** During the 2015-16 interim, the legislative management shall consider
16 studying the maintenance and repair of state property and the source of funds to be used for
17 maintenance and repair costs. The study must review current processes being used by state
18 agencies to identify and address maintenance and repairs of state property and the
19 appropriateness of the source of funds being used for these maintenance and repair projects.
20 The legislative management shall report its findings and recommendations, together with any
21 legislation required to implement the recommendations, to the sixty-fifth legislative assembly.

22 **SECTION 6. EMERGENCY.** The capital assets line item in section 1 of this Act is declared
23 to be an emergency measure.
