### **ENGROSSED SENATE BILL NO. 2001**

- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
- 2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota

3 Century Code, relating to the salaries of the governor and lieutenant governor.

### 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
as may be necessary, are appropriated out of any moneys in the general fund in the state
treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying
the expenses of the office of the governor, for the biennium beginning July 1, 2015, and ending
June 30, 2017, as follows:

- 6 The 2015-17 one-time funding amounts are not a part of the entity's base budget for the
- 7 2017-19 biennium. The office of the governor shall report to the appropriations committees of
- 8 the sixty-fifth legislative assembly on the use of this one-time funding for the biennium
- 9 beginning July 1, 2015, and ending June 30, 2017.

10 SECTION 3. APPROPRIATION - GOVERNOR'S OFFICE. In addition to the amounts

appropriated to the governor's office in section 1 of this Act, there is appropriated any additional

12 income from federal or other funds which may become available to the agency for the biennium

- 13 beginning July 1, 2015, and ending June 30, 2017.
- 14 SECTION 4. AMENDMENT. Section 54-07-04 of the North Dakota Century Code is
- 15 amended and reenacted as follows:

# 16 54-07-04. Salary of governor.

- 17 The annual salary of the governor is one hundred twenty-one thousand six hundred
- 18 eighty-one dollars through June 30, 2014, and one hundred twenty-five thousand three hundred
- 19 thirty-one one hundred twenty-nine thousand ninety-one dollars through June 30, 2016, and one

20 <u>hundred thirty-two thousand nine hundred sixty-four</u> dollars thereafter.

- 21 SECTION 5. AMENDMENT. Section 54-08-03 of the North Dakota Century Code is
- 22 amended and reenacted as follows:

# 23 **54-08-03. Salary of lieutenant governor.**

- 24 The annual salary of the lieutenant governor is ninety-four thousand four hundred sixty-two-
- 25 dollars through June 30, 2014, and ninety-seven thousand two hundred ninety-sixone hundred
- 26 thousand two hundred fifteen dollars through June 30, 2016, and one hundred three thousand
- 27 <u>two hundred twenty-one</u> dollars thereafter.
