Page 1, line 2, remove the first "and"

Page 1, line 3, after the second "governor" insert "; and to provide for a legislative management report"

Page 1, replace line 12 with:

"Salaries and wages \$3,540,985 \$320,564 \$3,861,549"

Page 1, replace line 19 with:

"Total general fund \$4,033,873 \$317,842 \$4,351,715"

Page 2, replace lines 10 through 13 with:

"SECTION 3. APPROPRIATION - GOVERNOR'S OFFICE - LEGISLATIVE MANAGEMENT REPORT. In addition to the amounts appropriated to the governor's office in section 1 of this Act, there is appropriated to the governor's office, any additional income from federal or other funds which may become available to the governor's office, for the biennium beginning July 1, 2015, and ending June 30, 2017. Any funds received under this section must be used for the specific purpose intended for the funds or transferred to the appropriate state agency or institution. Upon the receipt of funds under this section, the governor's office shall provide a report to the legislative management regarding the source, amount, and purpose of the funds received."
