Require NDUS to include the date of birth and residential address on student identification cards on new cards issued after 12/31/15. Also, requires NDUS to provide each student with information regarding voter eligibility requirements.

Section 1 will cause NDUS campuses to re-issue cards to all students (and staff) to include the required information. Even though amendments require cards after 12/31/15 to have required data, the NDUS would plan for a Fall 2015 implementation to ensure all students have consistent cards for the full academic year. This is required at many campuses since the card also serves other purposes such as an electronic key.

15-17: Estimated cost to re-issue cards to all students (and staff) are \$510,000 compared to current 13-15 estimated expenditures of \$135,000 or an increase of \$375,000. Includes the cost to replace current card systems (and related point of sale systems) at some campuses as current will not accommodate required additional information; replacement of current card stock; re-design of cards; higher number of re-issued cards due to change of address; added administrative costs, etc..

17-19: Estimated cost to issue cards to new students, lost cards, replacement cards based on change of address, etc. is \$256,000 or \$121,000 more than current 13-15 costs.

No changes to above estimates based on amended delay to 12/31/15, as continue to assume card changes would be put in place for the Fall 2015 semester.
