- 1 A BILL for an Act to create and enact chapter 9-15.2 of the North Dakota Century Code, relating
- 2 to the Revised Uniform Athlete Agents Act; to repeal chapter 9-15.1 of the North Dakota Century
- 3 Code, relating to the Uniform Athlete Agents Act; and to provide a penalty.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:
