1	A BILL for an Act to amend and reenact section 12.1-20-12.1, subsection 2 of section		
2	12.1-20-12.2, and subsection 4 of section 12.1-27.2-01 of the North Dakota Century Code,		
3	relating to indecent exposure toward minors, surreptitious intrusion, and sexual performances		
4	by children; and to provide a penalty.		
5	BE IT E	NAC	TED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:
6	SECTION 1. AMENDMENT. Section 12.1-20-12.1 of the North Dakota Century Code is		
7	amended and reenacted as follows:		
8	12.1-20-12.1. Indecent exposure.		
9	1.	A p	erson, with intent to arouse, appeal to, or gratify that person's lust, passions, or
10		sex	ual desires, is guilty of a class A misdemeanor if that person:
11		a.	Masturbates in a public place or in the presence of a minor; er
12	I	b.	Exposes one's penis, vulva, or anus in a public place or to a minor in a public or
13			private place .; or
14		<u>C.</u>	Exposes one's penis, vulva, or anus by unsolicited electronic means or by
15			electronic means to a minor. Electronic means include images and pictures
16			transmitted via electronic mail, electronic messaging, or from an electronic
17			communications device.; or
18		d.	Exposes one's penis, vulva, or anus by any electronic means to a minor.
19	2.	A p	erson is guilty of a class C felony if the person violates subsection 1 after a
20		pre	vious conviction for violating subsection 1, after a previous conviction for violating
21		sec	tion 12.1-20-12.2, or after being required to register under section 12.1-32-15.
22	3.	A p	erson who commits a violation of subdivision a or b of subsection 1 within fifty feet

A person who commits a violation of <u>subdivision a or b of</u> subsection 1 within fifty feet

[15.24 meters] of or on the real property comprising a public or nonpublic elementary,

middle, or high school is guilty of a class C felony. A person who commits a violation of

1		subsection 2 within fifty feet [15.24 meters] of or on the real property comprising a		
2		public or nonpublic elementary, middle, or high school is guilty of a class B felony.		
3	4.	The act of a woman discreetly breastfeeding her child is not a violation of this section.		
4	5.	As used in this section, "electronic means" includes images and picture transmitted via		
5		electronic mail, electronic messaging, or from an electronic communications device.		
6	SECTION 2. AMENDMENT. Subsection 2 of section 12.1-20-12.2 of the North Dakota			
7	Century Code is amended and reenacted as follows:			
8	2.	A person is guilty of a class C felony if the person violates subsection 1 after a		
9		previous conviction for violating subsection 1, after a previous conviction for violating		
10		section 12.1-20-12.1, or after being required to register under section 12.1-32-15, or if		
11		the victim is a minor.		
12	SECTION 3. AMENDMENT. Subsection 4 of section 12.1-27.2-01 of the North Dakota			
13	Century Code is amended and reenacted as follows:			
14	4.	"Sexual conduct" means actual or simulated sexual intercourse, sodomy, sexual		
15		bestiality, masturbation, sadomasochistic abuse, or lewd exhibition of the buttocks,		
16	breasts, or genitals, including the further definitions of sodomy and sadomasochistic-			
17	abuse under section 12.1-27.1-01.:			
18		a. Sexual intercourse;		
19		b. Sodomy, as defined under section 12.1-27.1-01;		
20		c. Sexual bestiality;		
21		d. Masturbation;		
22		e. Sadomasochistic abuse, as defined under section 12.1-27.1-01;		
23		f. Lewd exhibition of the buttocks, breasts, or genitals;		
24		g. Nude or partially denuded human figure, as defined in section 12.1-27.1-03.1, if		
25		depicted for the purpose of the sexual stimulation or the sexual gratification of		
26		any individual who many view such depiction; or		
27		h. Physical contact with a person's clothed or unclothed genitals, pubic area,		
28		buttocks, or breasts. It is not necessary that the minor know that he or she is		
29		participating in the described conduct, or any aspect of it.
