- 1 A BILL for an Act to amend and reenact section 15.1-21-02.6 of the North Dakota Century
- 2 Code, relating to eligibility for North Dakota scholarships.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 15.1-21-02.6 of the North Dakota Century Code is
amended and reenacted as follows:

6 15.1-21-02.6. North Dakota scholarship - Amount - Applicability.

The state board of higher education shall provide to any student certified as а. 8 being eligible by the superintendent of public instruction either a North Dakota 9 academic scholarship or a North Dakota career and technical education 10 scholarship in the amount of seven hundred fifty dollars for each semester during 11 which the student is enrolled full time at an accredited institution of higher 12 education in this state and, maintains a cumulative grade point average of 2.75, 13 and maintains progress toward degree completion.
- 14b.The state board of higher education shall provide to any student certified as15being eligible by the superintendent of public instruction either a North Dakota16academic scholarship or a North Dakota career and technical education17scholarship in the amount of five hundred dollars for each quarter during which18the student is enrolled full time at an accredited institution of higher education in19this state and, maintains a cumulative grade point average of 2.75, and maintains20progress toward degree completion.
- 2. The state board shall monitor each scholarship recipient to ensure that the student
 meets the academic and other requirements of this section. Upon determining that a
 recipient student has failed to meet the requirements of this section, the board shall
 provide notification to the student within ten days.

1	(2) Students who graduated from high school during the 2009-10 or the
2	2010-11 school year and who have completed six semesters may retain
3	scholarship eligibility by enrolling in only twelve credits during each of the
4	student's final two semesters, or the equivalent number of credits, as
5	determined by the state board of higher education, with respect to students
6	in a quarter system.
7	(3) The requirement that a student be enrolled in at least fifteen credits, or at
8	least fourteen credits if enrolled in a nursing program, as set forth in
9	subdivision a, does not apply in the case of a student participating in a
10	clinical, practicum, internship, cooperative program, or similar external
11	experience, provided:
12	(a) The external experience is equivalent to at least six credits, or such
13	similar amount as determined by the state board of higher education,
14	with respect to students in a quarter system; and
15	(b) The credits for the external experience, together with any other credits
16	in which the student is enrolled, total at least twelvehas the same
17	meaning as the term is defined by the institution the student is
18	attending.
19	b. For the purpose of North Dakota scholarship eligibility under this section,
20	"progress toward degree completion" means earning the following minimum
21	number of credits after each semester or quarter term disbursement to qualify for
22	the subsequent disbursement:
23	(1) Twelve credits after disbursement one;
24	(2) Twenty-four credits after disbursement two;
25	(3) Thirty-nine credits after disbursement three;
26	(4) Fifty-four credits after disbursement four;
27	(5) Sixty-nine credits after disbursement five;
28	(6) Eighty-four credits after disbursement six; and
29	(7) Ninety-nine credits after disbursement seven.
