- 1 A BILL for an Act to amend and reenact sections 24-05-04 and 48-01.2-07 of the North Dakota
- 2 Century Code, relating to highway improvement contracts to be advertised; and to repeal
- 3 section 24-05-04.2 of the North Dakota Century Code, relating to contracts for road
- 4 construction.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Section 24-05-04 of the North Dakota Century Code is
 7 amended and reenacted as follows:

8 24-05-04. Contracts to be advertised - <u>Road construction -</u> Requirements for rental 9 contracts.

- 10 1. If a contract for a highway improvement exceeds one hundred thousand dollars, the
- 11 board of county commissioners shall seek bids by publishing an advertisement at least
- 12 once each week for two consecutive weeks in the official newspaper of the county and
- 13 <u>in other newspapers as the board deems advisable. The first publication must be</u>
- 14 <u>made at least fifteen days before the day set for the opening of the bids. For any</u>
- 15 <u>contract for a highway improvement that exceeds fifty thousand dollars but does not</u>
- 16 <u>exceed one hundred thousand dollars, the county, when possible, shall seek quotes</u>
- 17 <u>from at least two contractors.</u>
- A purchase of county road machinery and any rental contract or agreement for the use
 of road machinery and other articles, except necessary repairs for road machinery,
- 20 which exceeds the sum of fifty thousand dollars must be advertised as provided by law-
- 21 for the purchase of county supplies by publishing an advertisement for bids at least
- 22 once each week for two consecutive weeks in the official newspaper of the county and
- 23 <u>in any other newspapers as the board deems advisable</u>. The first publication must be
- 24 <u>made at least fifteen days before the day set for the opening of the bids.</u> The board of

1		county commissioners may not enter a rental contract or agreement for the use of
2		road machinery and other articles for a longer period than twelve months from the date
3		of the rental contract or agree to pay rental for the use of road machinery and other
4		articles which would result in the lessor receiving rental at a rate in excess of twenty
5		percent per year of the cash sale price of the road machinery or other articles. The
6		cash sale price of the road machinery and other articles must be clearly set forth in
7		any rental contract for road machinery and other articles and failure to include this
8		data in any rental contract for the use of road machinery and other articles renders the
9		rental contract void. A payment made under a void rental contract is recoverable from
10		the county commissioners making the contract, jointly and severally.
11	2. 3.	Notwithstanding the provisions of this section relating to the duration of rental
12		contracts, the board of county commissioners may enter lease-purchase agreements
13		for the road machinery and articles covered by this section if those agreements
14		provide for the complete performance and full payment of the purchase price of the
15		machinery or articles within seven years from the date of the execution of the
16		lease-purchase agreement according to section 44-08-01.1.
17	<u>4.</u>	Bids received under this section must be opened and awarded under the procedure
18		provided in section 48-01.2-07.
19	SECTION 2. AMENDMENT. Section 48-01.2-07 of the North Dakota Century Code is	
20	amended and reenacted as follows:	
21	48-01.2-07. Opening of bids - Award of contract.	
22	At the time and place specified in the notice, a governing body <u>or its designated agent</u> shall	
23	open publicly and read aloud each responsible bid receivedand. The governing body shall	
24	award the contract to the lowest responsible bidder. A governing body may reject any and all	
25	bids and readvertise for bids if no bid is satisfactory or if the governing body determines any	
26	agreement has been entered by the bidders or others to prevent competition. The governing	
27	body may advertise for new bids in accordance with this chapter until a satisfactory bid is	
28	received	l.
