- 1 A BILL for an Act to amend and reenact sections 54-60.2-01 and 54-60.2-02 of the North
- 2 Dakota Century Code, relating to workforce development grants for tribally controlled
- 3 community colleges; and to provide an appropriation.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1. AMENDMENT.** Section 54-60.2-01 of the North Dakota Century Code is amended and reenacted as follows:

54-60.2-01. Establishment of workforce development grant for tribally controlled community colleges.

There is established within the division of workforce development of the department of commerce a program to provide workforce development grants to tribally controlled community colleges in North Dakota. A tribally controlled community college in this state may apply to the department of commerce for a job training grant in such manner as the department of commerce prescribes. The department of commerce shall consult with the executive director of the Indian affairs commission to determine eligible tribally controlled community colleges and shall award grants based on the documented job placement rates at each eligible college.

SECTION 2. AMENDMENT. Section 54-60.2-02 of the North Dakota Century Code is amended and reenacted as follows:

54-60.2-02. (Effective through July 31, 2017) Purpose of grants.

- 1. Any grant awarded under section 54-60.2-01 may be used at the discretion of the college:
 - a. For development or enhancement of programs that assist in providing certificates or degrees to North Dakota students attending the college that qualify the student to obtain jobs for which applicants are being sought within the state, as identified

1 by the department of commerce, job service North Dakota, or any of the federally 2 recognized Indian tribes within North Dakota; or 3 b. To assist any North Dakota student attending the college to establish, or to assist 4 in establishing, a new business operating within North Dakota that will employ 5 North Dakota citizens. 6 2. Any funds provided to tribally controlled community colleges must be used to 7 supplement, not supplant, any existing program or funding source of the college. 8 (Effective after July 31, 2017) Purpose of grants. Any grant awarded under section-9 54-60.2-01 may be used at the discretion of the college: 10 For development of programs that assist in providing certificates or degrees to North-11 Dakota students attending the college that qualify the student to obtain jobs for which-12 applicants are being sought within the state, as identified by the department of 13 commerce, job service North Dakota, or any of the federally recognized Indian tribes 14 within North Dakota; or 15 To assist any North Dakota student attending the college to establish, or to assist in-16 establishing, a new business operating within North Dakota that will employ North-17 Dakota citizens. 18 Any funds provided to tribally controlled community colleges must be used to supplement, 19 not supplant, any existing program or funding source of the college. 20 SECTION 3. APPROPRIATION. There is appropriated out of any moneys in the general 21 fund in the state treasury, not otherwise appropriated, the sum of \$1,500,000, or so much of the 22 sum as may be necessary, to the department of commerce for the purpose of providing 23 workforce grants to tribally controlled community colleges, for the biennium beginning July 1, 24 2017, and ending June 30, 2019. The funding provided in this section is considered a one-time 25 funding item.
