- 1 A BILL for an Act to create and enact a new section to chapter 15.1-21 of the North Dakota
- 2 Century Code, relating to parental directives; and to declare an emergency.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1.** A new section to chapter 15.1-21 of the North Dakota Century Code is created

5 and enacted as follows:

- 6 Parental directive - Administration of tests and assessments. 7 The superintendent of public instruction shall: 8 Respect The superintendent of public instruction shall respect and support the right of 1. 9 a parent to opt a child of the parent out of public school and any activity, practice, or 10 testing, with no interference from the state, which the parent finds unacceptable. 11 orsurvey or testing that is not a part of a curriculum, to which the parent has a 12 philosophical, moral, or religious objection. This subsection does not prohibit the state 13 from funding public education on a per-pupil basis. 14 A student's parent may direct that the school district in which the student is enrolled 2. 15 not administer to the student any state test or state assessment required in 16 accordance with sections section 15.1-21-08, 15.1-21-17, or 15.1-21-18.
- 17 <u>3.</u> <u>A child withheld from a test or assessment under this section is deemed to be in</u>
 18 <u>attendance for all purposes under this title.</u>
- 194.a.A parental directive is valid only if it is presented to the school district using a20standardized form, prepared by the superintendent of public instruction, and21signed by the student's custodial parent.
- 22b.A parental directive is valid only until the conclusion of the school year in which it23is received by the school district.
