- 1 A BILL for an Act to create and enact three new sections to chapter 16.1-08.1 of the North
- 2 Dakota Century Code, relating to campaign disclosure statements and use of campaign
- 3 contributions; to amend and reenact section 16.1-08.1-01, subsections 6 and 7 of section
- 4 16.1-08.1-02.1, sections 16.1-08.1-03.1 and 16.1-08.1-03.3, subsection 3 of section
- 5 16.1-08.1-05, and subsection 5 of section 16.1-12-02.2 of the North Dakota Century Code,
- 6 relating to definitions and campaign disclosure statements; to repeal sections 16.1-08.1-02,
- 7 16.1-08.1-03, 16.1-08.1-03.1, 16.1-08.1-03.8, 16.1-08.1-03.9, 16.1-08.1-03.10, 16.1-08.1-03.11,
- 8 16.1-08.1-03.12, 16.1-08.1-03.13, and 16.1-08.1-04 of the North Dakota Century Code, relating
- 9 to campaign disclosure statements; and to provide a penalty.

10 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 11 **SECTION 1. AMENDMENT.** Section 16.1-08.1-01 of the North Dakota Century Code is amended and reenacted as follows:
- 13 **16.1-08.1-01. Definitions.**

- As used in this chapter, unless the context otherwise requires:
- 15 "Affiliate" means an organization that controls, is controlled by, or is under common 1. 16 control with another organization. For purposes of this definition, control means the 17 possession, direct or indirect, of the power to direct or cause the direction of the 18 management and policies of an organization, whether through the ownership of voting 19 securities, by contract other than a commercial contract for goods or nonmanagement 20 services, or otherwise. Control is presumed to exist if an organization, directly or 21 indirectly, owns, controls, holds with the power to vote, or holds proxies representing 22 fifty percent or more of the voting securities of any other organization.
 - 2. "Association" means any club, association, union, brotherhood, fraternity, organization, or group of any kind of two or more persons, including labor unions, trade

- associations, professional associations, or governmental associations, which is united for any purpose, business, or object and which assesses any dues, membership fees, or license fees in any amount, or which maintains a treasury fund in any amount. The term does not include corporations, cooperative corporations, limited liability companies, political committees, or political parties.
 - 3. "Candidate" means an individual who seeks nomination for election or election to public office, and includes:
 - a. An individual holding public office;
 - An individual who has publicly declared that individual's candidacy for nomination for election or election to public office or has filed or accepted a nomination for public office;
 - c. An individual who has formed a campaign or other committee for that individual's candidacy for public office;
 - d. An individual who has circulated a nominating petition to have that individual's name placed on the ballot; and
 - e. An individual who has, in any manner, solicited or received a contribution for that individual's candidacy for public office, whether before or after the election for that office.
 - 4. "Conduit" means a person that is not a political party, political committee, or candidate and which receives a contribution of money and transfers the contribution to a candidate, political party, or political committee when the contribution is designated specifically for the candidate, political party, or political committee and the person has no discretion as to the recipient and the amount transferred. The term includes a transactional intermediary, including a credit card company or a money transfer service that pays or transfers money to a candidate on behalf of another person.
 - 5. "Contribution" means a gift, transfer, conveyance, provision, receipt, subscription, loan, advance, deposit of money, or anything of value, made for the purpose of influencing the nomination for election, or election, of any person to public office or aiding or opposing the circulation or passage of a statewide initiative or referendum petition or measure. The term also means a contract, promise, or agreement, express or implied, whether or not legally enforceable, to make a contribution for any of the

- above purposes. The term includes funds received by a candidate for public office or a political party or committee which are transferred or signed over to that candidate, party, or committee from another candidate, party, or political committee or other source including a conduit. The term "anything of value" includes any good or service of more than a nominal value. The term "nominal value" means the cost, price, or worth of the good or service is trivial, token, or of no appreciable value. The term "contribution" does not include:
 - a. A loan of money from a bank or other lending institution made in the regular course of business.
 - b. Time spent by volunteer campaign or political party workers.
 - c. Money spent by a candidate on the candidate's own behalf.
- d.b. Money or anything of value received for commercial transactions, including rents, advertising, or sponsorships made as a part of a fair market value bargained-for exchange.
- e.c. Money or anything of value received by a candidate in that person's personal capacity, including pursuant to a contract or agreement made for personal or private employment purposes, and not received for anything other than a political purpose or to influence the performance of that person's official duty.
- f.d. Contributions of products Products or services for which the actual cost or fair market value are reimbursed by a payment of money.
- g.e. An independent expenditure.
 - f. The value of advertising paid by a political party, multicandidate political
 committee, or caucus which is in support of a candidate.
- 6. "Cooperative corporations", "corporations", and "limited liability companies" are as defined in this code, and for purposes of this chapter "corporations" includes nonprofit corporations. However, if a political committee, the only purpose of which is accepting contributions and making expenditures for a political purpose, incorporates for liability purposes only, the committee is not considered a corporation for the purposes of this chapter.
- 7. "Expenditure" means:

1 A gift, transfer, conveyance, provision, loan, advance, payment, distribution, 2 disbursement, outlay, or deposit of money or anything of value, except a loan of 3 money from a bank or other lending institution made in the regular course of 4 business, made for a political purpose or for the purpose of influencing the 5 passage or defeat of a measure. 6 A contract, promise, or agreement, express or implied, whether or not legally b. 7 enforceable, to make any expenditure. 8 The transfer of funds by a political committee to another political committee. C. 9 d. An independent expenditure.;; 10 8. "Incidental committee" means a committee, club, association, or other group of 11 persons that makes a contribution or expenditure, but for which making contributions 12 and expenditures for political purposes is not its primary purpose. "Expenditure 13 categories" means the categories into which expenditures must be grouped for reports 14 under this chapter. The expenditure categories are: 15 <u>a.</u> Advertising; 16 <u>b.</u> Campaign loan repayment; 17 Consulting; <u>C.</u> 18 <u>d.</u> Operations: 19 <u>e.</u> Postage; 20 <u>f.</u> Printing: 21 Travel; and g. 22 Miscellaneous. h. 23 "Independent expenditure" means an expenditure made for a political purpose or for 9. 24 the purpose of influencing the passage or defeat of a measure if the expenditure is 25 made without the express or implied consent, authorization, or cooperation of, and not 26 in concert with or at the request or suggestion of, any candidate or a candidate, 27 committee, or measure committeepolitical party. 28 10. "Patron" means a person who owns equity interest in the form of stock, shares, or

- A candidate committee, established to support an individual candidate seeking statewide, judicial, or legislative public office which solicits or receives contributions for political purposes;

 with the federal election commission, which solicits or receives contributions or
 makes expenditures for political purposes;
- d. A multicandidate political committee, established to support multiple groups or slates of candidates seeking public office, thatwhich solicits or receives contributions for political purposes; and

A measure committee, including an initiative or referendum sponsoring committee at any stage of its organization, which solicits or receives contributions or makes expenditures for the purpose of aiding or opposing a measure sought to be voted upon by the voters of the state, including any activities undertaken for the purpose of drafting an initiative or referendum petition, seeking approval of the secretary of state for the circulation of a petition, or seeking approval of the submitted petitions; and

- 1 **SECTION 6. AMENDMENT.** Section 16.1-08.1-03.1 of the North Dakota Century Code is 2 amended and reenacted as follows:
- 3 16.1-08.1-03.1. Contributions statementSpecial requirements for statements required of measure committees circulating or promoting passage or defeat of initiated or referred measure.
 - 1. Any person or measure committee, as described in section 16.1-08.1-01, that is soliciting or accepting a contribution for the purpose of aiding or opposing the circulation or passage of a statewide initiative or referendum petition or measure placed upon a statewide ballot by action of the legislative assembly at any electionshall file a statement in accordance with this subsection if the person has received any contribution in excess of one hundred dollars. The statement must include the nameand mailing address of each person that contributed in excess of one hundred dollarsto the person, the amount of each reportable contribution, and the date each reportable contribution was received. The statement must include the name and mailing address of each recipient of an expenditure exceeding one hundred dollars in the aggregate, the amount of each reportable expenditure, and the date the expenditure was made.
 - A person or measure committee as described in section 16.1-08.1-01 which is soliciting or accepting a contribution for the purpose of aiding or opposing the circulation or passage of a statewide initiative or referendum petition or measureplaced upon a statewide ballot by action of the legislative assembly may not accept a contribution of more than one hundred dollars from an out-of-state person or politicalcommittee unless the contribution is accompanied by a certified statement from the contributor listing the name, address, and amount contributed by each person that contributed more than one hundred dollars of the contribution. The statement must indicate if no person contributed in excess of one hundred dollars of the out-of-state person's or political committee's overall contribution. The certified statement must also list the occupation, employer, and principal place of business for each individual whocontributed more than one hundred dollars of the contribution. The person soliciting or accepting a contribution for the purpose of aiding the circulation of a statewideinitiative or referendum petition or of promoting passage or defeat of a statewide

- initiated or referred measure shall include this statement with the contribution
 statement required to be filed under subsection 1.
 - 3. The statement required of a person or measure committee under subsection 1 mustbe filed with the secretary of state no later than the thirty-second day before the dateof the election in which the measure appears or would have appeared on the ballot
 complete from the beginning of that calendar year through the fortieth day before the
 date of the election. A complete statement for the entire calendar year for eachstatement required to be filed under this section must be filed no later than thethirty-first day of January of the following year. Even if a person required to reportaccording to this section has not received any contributions in excess of one hundreddollars during the reporting period, the person shall file a statement as required by thischapter. A statement filed according to this section during the reporting period mustshow the following:
 - a. The gross total of all contributions received and expenditures made in excess of one hundred dollars;
 - b. The gross total of all contributions received and expenditures made of one hundred dollars, or less; and
 - c. The cash on hand in the filer's account at the start and close of the reporting periodFor each reportable contribution under section 4 of this Act, the threshold for reporting is one hundred dollars for any person or measure committee circulating or promoting passage or defeat of an initiated or referred measure.
 - 2. For contributions received from an out-of-state contributor, a person or measure committee circulating or promoting passage or defeat of an initiated or referred measure shall include the following information regarding subcontributors in the statements required under section 5 of this Act:
 - a. A designation as to whether any person contributed in excess of one hundred dollars of the total contribution;
 - <u>b.</u> The name and mailing address of each subcontributor that contributed in excess
 of one hundred dollars of the total contribution;
 - c. The contribution amounts of each disclosed subcontributor; and

1 The occupation, employer, and address for the employer's principal place of 2 business of each disclosed subcontributor. 3 <u>3.</u> An initiative and referendum sponsoring committee also shall file a disclosure 4 statement by the date the secretary of state approves the petition for circulation, and 5 shall file an additional statement on the date the petitions containing the required 6 number of signatures are submitted to the secretary of state for review. The 7 statements required under this subsection must be in the same form as the year-end 8 statements under section 5 of this Act. 9 A sponsoring committee shall file a statement regarding its intent to compensate 10 circulators before paying for petitions to be circulated. 11 **SECTION 7. Campaign contributions by corporations, cooperative corporations, 14 limited liability companies, and associations - Violation - Penalty - Political action 15 committees authorized. 16 A corporation, cooperative corporation, limited liability company, or association may 17 establish, administer, and solicit contributions to a separate and segregated fund to be 18 utilized for political purposes by the corporation, cooperative corporation, limited 19 liability company, or association. It is unlawful for: 20 The person or persons controlling the fund to make contributions or expenditures a. 21 utilizing money or anything of value secured by physical force, job discrimination, 22 financial reprisals, or the threat of them; or utilize money from dues, fees, 23 treasury funds, or other money required as a condition of membership in an 24 association, or as a condition of employment; or utilize money obtained in any 25 commercial transaction. Moneys from fees, dues, treasury funds, or money 26 obtained in a commercial transaction may, however, be used to pay costs of 27 administration of the fund. 28 Any person soliciting an employee, stockholder, patron, board member, or b. 29 member for a contribution to the fund to fail to inform the employee or member of

the political purposes of the fund at the time of the solicitation or of the general

political philosophy intended to be advanced through committee activities.

- 1 c. Any person soliciting an employee or member for a contribution to the fund to fail
 2 to inform the employee or member at the time of the solicitation of the right to
 3 refuse to contribute without any reprisal.
 - d. Any contribution to be accepted without keeping an accurate record of the contributor and amount contributed and of amounts expended for political purposes.
 - e. Any contribution to be accepted from any person who is not an employee, a stockholder, a patron, a board member or a member of the corporation, cooperative corporation, limited liability company, or association maintaining the political action committee, except a corporation may accept a contribution from an employee, a stockholder, a patron, a board member, or a member of an affiliate or a subsidiary of the corporation.
 - f. Any expenditure made for political purposes to be reported under this section before control of the expenditure has been released by the political action committee except if there is a contract, a promise, or an agreement, expressed or implied, to make such expenditure.
 - 2. All political action committees, as described in section 16.1-08.1-01, formed for the purpose of administering the segregated fund provided for in this section shall file a statement showing the name and mailing address of each contributor of an amount in excess of two hundred dollars in the aggregate for the reporting period and a listing of all expenditures of an amount in excess of two hundred dollars in the aggregate made for political purposes with the secretary of state. The statement must include the amount of each reportable contribution and the date it was received and the amount of each reportable expenditure and the date it was made. A year-end statement covering the entire calendar year must be filed no later than the thirty-first day of January of the following year. A pre-election statement must be filed no later than the thirty-second day before any primary, special, or general election and must be complete from the beginning of the calendar year through the fortieth day before the election. Even if a political action committee has not received any contributions or made any expenditures in excess of two hundred dollars during the reporting period, the political

If an officer, employee, agent, attorney, or other representative of a corporation, 20 cooperative corporation, limited liability company, or association makes any 21 contribution prohibited by this section out of corporate, cooperative corporation, limited 22 liability company, or association funds or otherwise violates this section, it is prima 23 facie evidence of a violation by the corporation, cooperative corporation, limited liability 24 company, or association. 25 6.4. A violation of this section may be prosecuted in the county where the contribution is 26 made or in any county in which it has been paid or distributed. 27 7.5. It is a class A misdemeanor for an officer, director, stockholder, manager, governor, 28 member, attorney, agent, or representative of any corporation, cooperative 29 corporation, limited liability company, or association to violate this section or to counsel

- 1 Any officer, director, stockholder, manager, governor, member, attorney, agent, or 2 representative who makes, counsels, or consents to the making of a contribution in 3 violation of this section is liable to the company, corporation, limited liability company, 4 or association for the amount so contributed.
- 5 SECTION 8. A new section to chapter 16.1-08.1 of the North Dakota Century Code is 6 created and enacted as follows:

7 Personal use of contributions prohibited.

- 8 A candidate may not use any contribution received by the candidate, the candidate's
- 9 candidate committee, or a multicandidate political committee to:
- 10 1. Give a personal benefit to the candidate or another person;
- 11 <u>2.</u> Make a loan to another person;
- 12 <u>3.</u> Knowingly pay more than the fair market value for goods or services purchased for the 13 campaign; or
- 14 Pay a criminal fine or civil penalty.

- 15 SECTION 9. AMENDMENT. Subsection 3 of section 16.1-08.1-05 of the North Dakota 16 Century Code is amended and reenacted as follows:
- 17 An audit may not be made or requested of a statement for the sole reason that it was 18 not timely filed with the secretary of state. An audit made or arranged according to this 19 section must audit only those items required to be included in any statement, 20 registration, or report filed with the secretary of state according to this chapter. The secretary of state may collect any payment obligation arising out of this section by civil 22 action or by assignment to a collection agency, with any costs of collection to be 23 added to the amount owed and to be paid by the delinquent filer. Any remaining 24 moneys collected by the secretary of state after an audit is paid for under this section 25 must be deposited in the state's general fund. This section does not apply to 26 statements filed according to sections 16.1-08.1-03.10 and under section 27 16.1-08.1-03.11 or to statements filed by candidates for county office or by candidate 28 committees for candidates for county office.
 - SECTION 10. AMENDMENT. Subsection 5 of section 16.1-12-02.2 of the North Dakota Century Code is amended and reenacted as follows:

Sixty-fifth Legislative Assembly

1 An individual who intends to be a write-in candidate for any legislative district office 2 shall file a certificate of write-in candidacy with the secretary of state. The certificate 3 must contain the name, address, and signature of the candidate. Certificates must be 4 filed by four p.m. on the fourth day before the election. When the candidate files a 5 certificate, the candidate also shall file the contribution statement provided for under 6 section 16.1-08.1-024 of this Act complete through the day of the filing of the 7 certificate. 8 **SECTION 11.
