- 1 A BILL for an Act to amend and reenact sections 50-06-21 and 50-06-22 and subsection 4 of
- 2 section 53-12.1-09 of the North Dakota Century Code, relating to gambling disorder prevention,
- 3 awareness, crisis intervention, rehabilitation, and treatment services.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 50-06-21 of the North Dakota Century Code is amended and reenacted as follows:
- 50-06-21. Compulsive gambling Gambling disorder prevention, awareness, crisis
  intervention, rehabilitation, and treatment services.

The department of human services shall contract with qualified treatment service providers for the development and implementation of a program for gambling prevention, awareness, crisis intervention, rehabilitation, financial counseling, and mental health treatment services. The program may provide outpatient services, partial care services, aftercare services, intervention services, financial counseling services, consultation services, or other forms of preventive, rehabilitative, or treatment services for compulsive gamblers individuals with a gambling disorder. An individual who provides treatment services must be a mental health professional asdefined in section 25-03.1-02 and meet the minimum standards for certification as a gamblingcounselor as established by rule by that mental health professional's licensing boardlicensed professional operating within the individual's scope of practice. An individual who provides financial counseling services must be a certified consumer credit counselor with an accredited financial counseling agency. The department of human services may establish a sliding payment scale for services under the program. The department of human services may establish a centrally located repository of educational materials on identifying and treating compulsive gambling disorders. Any service fee collected by qualified treatment service providers for services provided under the contract must be applied toward the program's

| 8  | loss of control over gambling behaviors, and oftentimes disregard for the negative                        |  |
| 9  | consequences as a result of gambling. Gambling disorder includes gambling behavior that                   |  |
| 10 | compromises, disrupts, or damages personal, family, or vocational pursuits.                               |  |
| 11 | SECTION 2. AMENDMENT. Section 50-06-22 of the North Dakota Century Code is                                |  |
| 12 | amended and reenacted as follows:   |  |
| 13 | 50-06-22. Compulsive gambling Gambling disorder prevention and treatment fund -                           |  |

| 15 | Funds deposited in the <del>compulsive</del> gambling <u>disorder</u> prevention and treatment fund under |  |
| 16 | section 53-12.1-09 are appropriated to the department on a continuing basis for the purpose of            |  |

| 18 | SECTION 3. AMENDMENT. Subsection 4 of section 53-12.1-09 of the North Dakota                              |  |
| 19 | Century Code is amended and reenacted as follows:   |  |
| 20 | 4. Tra  | nsfer of net proceeds:   |
| 21 | a.  | Eighty thousand dollars must be transferred to the state treasurer each quarter                  |
| 22 |   | for deposit in the <del>compulsive</del> gambling <u>disorder</u> prevention and treatment fund; |
| 23 | b.  | An amount for the lottery's share of a game's prize reserve pool must be                         |
| 24 |   | transferred to the multistate lottery association;   |
| 25 | C.  | Starting July 1, 2007, one hundred five thousand six hundred twenty-five dollars                 |
| 26 |   | must be transferred to the state treasurer each quarter for deposit in the attorney              |
| 27 |   | general multijurisdictional drug task force grant fund; and                                      |
| 28 | d.  | The balance of the net proceeds, less holdback of any reserve funds the director                 |
| 29 |   | may need for continuing operations, must be transferred to the state treasurer on                |
