

SENATE BILL NO. 2072

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
2 transportation; to amend and reenact section 24-02-37 of the North Dakota Century Code,
3 relating to state highway fund expenditures; to provide for a transfer; and to provide
4 exemptions.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
7 as may be necessary, are appropriated from special funds derived from federal funds and other
8 income, to the department of transportation for the purpose of defraying the expenses of the
9 department of transportation, for the biennium beginning July 1, 2017, and ending June 30,
10 2019, as follows:

10 **SECTION 3. LINE ITEM TRANSFERS.** The director of the department of transportation
11 may transfer between the salaries and wages, operating, capital assets, and grants line items in
12 section 1 of this Act when it is cost-effective for construction and maintenance of highways. The
13 department of transportation shall notify the office of management and budget of any transfers
14 made pursuant to this section.

15 **SECTION 4. FUNDING FOR FEDERAL MATCH COSTS.** \$12,600,000, or so much of the
16 sum as may be necessary, of the funding provided in section 4 of chapter 12 of the 2015
17 Session Laws may be used to pay state match costs for federal highway funding provided by
18 the federal highway administration during the biennium beginning July 1, 2017, and ending
19 June 30, 2019.

20 **SECTION 5. ENHANCED STATE HIGHWAY INVESTMENTS - CARRYOVER**

21 **AUTHORITY.** Section 54-44.1-11 does not apply to funding of \$503,115,558 in the capital
22 assets line item relating to enhanced state highway investments in section 1 of chapter 12 of
23 the 2015 Session Laws. Any funds not spent by June 30, 2019, must be continued into the
24 biennium beginning July 1, 2019, and ending June 30, 2021, and may be expended only for
25 enhanced state highway investments.

26 **SECTION 6. EXEMPTION - CONTINGENT TRANSFER - GENERAL FUND TO SPECIAL**

27 **ROADS FUND.** The amount appropriated to the department of transportation from the general
28 fund for special road projects, as contained in section 6 of chapter 12 of the 2015 Session
29 Laws, is not subject to the provisions of section 54-44.1-11. Any unexpended funds from this
30 appropriation are available to the department of transportation for special road projects during
31 the biennium beginning July 1, 2017, and ending June 30, 2019.

1 **SECTION 7. AMENDMENT.** Section 24-02-37 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **24-02-37. State highway fund - Priorities for expenditure - Use of investment income.**

4 The state highway fund, created by law and not otherwise appropriated and allocated, must
5 be applied and used for the purposes named in this section, as follows:

6 1. Except for investment income as provided in subsection 3, the fund must be applied in
7 the following order of priority:

8 a. The cost of maintaining the state highway system.

9 b. The cost of construction and reconstruction of highways in the amount necessary
10 to match, in whatever proportion may be required, federal aid granted to this
11 state by the United States government for road purposes in North Dakota.

12 Notwithstanding any other provisions of law, the department of transportation
13 may repay the United States department of transportation for previous related
14 expenditures out of current biennium appropriations so that the department may
15 reobligate the federal aid to other federal aid projects.

16 c. Any portion of the highway fund not allocated as provided in subdivisions a and b
17 may be expended for the construction of state highways without federal aid or
18 may be expended in the construction, improvement, or maintenance of such
19 state highways.

20 2. All funds heretofore appropriated or hereafter appropriated or transferred to the
21 department, whether earmarked or designated for special projects or special purposes
22 or not, must be placed or transferred into a single state highway fund in the office of
23 the state treasurer and any claims for money expended by the department upon
24 warrants prepared and issued by the office of management and budget and signed by
25 the state auditor under this title must be paid out of the state highway fund by the state
26 treasurer; provided, however, that the commissioner shall keep and maintain complete
27 and accurate records showing that all expenditures have been made in accordance
28 with legislative appropriations and authorizations.

29 3. The state treasurer shall deposit the moneys in the state highway fund in an
30 interest-bearing account at the Bank of North Dakota. The state treasurer shall deposit
31 eighty percent of the income derived from the interest-bearing account in a special

1 interest-bearing account in the state treasury known as the special road fund. The
2 special road fund may be used, within the limits of legislative appropriation, exclusively
3 for the construction and maintenance of access roads to and roads within recreational,
4 tourist, and historical areas as designated by the special road committee. A political
5 subdivision or state agency may request funds from the special road fund by applying
6 to the committee on forms designated by the committee. The committee may require
7 the political subdivision or state agency to contribute to the cost of the project as a
8 condition of any expenditure authorized from the special road fund. Any moneys in the
9 fund not obligated by the special road committee by June thirtieth of each
10 odd-numbered year must be held for an additional two years after which the funds
11 revert to the state highway fund.
