**REMARKS BY PRESIDENT SANFORD**

Health to the Department of Public Instruction and Higher Ed. From Game & Fish and Park & Rec to the Commerce Dept and the Bank of ND. Community infrastructure, resources, education and economic development will all come together to help build vibrant communities.

I am very honored to be able to represent the people of North Dakota for the next 4 years as the 38th Lieutenant Governor. I am also very humbled and honored to serve as the President for this great institution we are standing in today – The North Dakota State Senate. I will perform my duties faithfully and respectfully and hope to have some fun along the way.
