1 A BILL for an Act to amend and reenact sections 15.1-21-02 and 15.1-21-02.2 of the North  
2 Dakota Century Code, relating to public and nonpublic high schools offering elective instruction  
3 on the Bible.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 15.1-21-02 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **15.1-21-02. High schools - Required units.**

8 1. ~~In order to~~To be approved by the superintendent of public instruction, each public and  
9 nonpublic high school shall make available to each student:

10 a. Four units of English language arts from a sequence that includes literature,  
11 composition, and speech;

12 b. Four units of mathematics, including:

13 (1) One unit of algebra II; and

14 (2) One unit for which algebra II is a prerequisite;

15 c. Four units of science, including:

16 (1) One unit of physical science; and

17 (2) One unit of biology;

18 d. Four units of social studies, including:

19 (1) One unit of world history;

20 (2) One unit of United States history; and

21 (3) (a) One unit of problems of democracy; or

22 (b) One-half unit of United States government and one-half unit of  
23 economics;

24 e. One-half unit of health;

- 1           f. One-half unit of physical education during each school year, provided that once  
2           every four years the unit must be a concept-based fitness class that includes  
3           instruction in the assessment, improvement, and maintenance of personal  
4           fitness;
- 5           g. Two units of fine arts, at least one of which must be music;
- 6           h. Two units of the same foreign or native American language;
- 7           i. One unit of an advanced placement course or one unit of a dual-credit course;
- 8           and
- 9           j. Two units of career and technical education from a coordinated plan of study  
10          recommended by the department of career and technical education and  
11          approved by the superintendent of public instruction; and
- 12          k. One-half unit of the old testament of the Bible or the new testament of the Bible,  
13          or one-half unit of instruction covering both the old and new testaments of the  
14          Bible.
- 15          2. In addition to the requirements of subsection 1, each public and nonpublic high school  
16          shall make available to each student, at least once every two years, one-half unit of  
17          North Dakota studies, with an emphasis on the geography, history, and agriculture of  
18          this state.
- 19          3. Each unit ~~which~~that must be made available under this section must meet or exceed  
20          the state content standards.
- 21          4. For purposes of this section, unless the context otherwise requires, "make available"  
22          means that:
  - 23           a. Each public high school and nonpublic high school shall allow students to select  
24           units over the course of a high school career from a list that includes at least  
25           those required by this section;
  - 26           b. If a student selects a unit from the list required by this section, the public high  
27           school or the nonpublic high school shall provide the unit to the student; and
  - 28           c. The unit may be provided to the student through any delivery method not  
29           contrary to state law and may include classroom or individual instruction and  
30           distance learning options, including interactive video, computer instruction,  
31           correspondence courses, and postsecondary enrollment under chapter 15.1-25.

- 1           5.    The board of a school district may not impose any fees or charges upon a student for  
2           the provision of or participation in units as provided in this section, other than the fees  
3           permitted by section 15.1-09-36.
- 4           6.    If in order to meet the minimum requirements of this section a school district includes  
5           academic courses offered by a postsecondary institution under chapter 15.1-25, the  
6           school district shall:
  - 7           a.    Pay all costs of the student's attendance, except those fees that are permissible  
8           under section 15.1-09-36; and
  - 9           b.    Transport the student to and from the location at which the course is offered or  
10           provide mileage reimbursement to the student if transportation is provided by the  
11           student or the student's family.
- 12          7.    The requirements of this section do not apply to alternative high schools or alternative  
13          high school education programs.
- 14          8.    The requirements of subdivisions g and h of subsection 1 do not apply to the North  
15          Dakota youth correctional center.

16          **SECTION 2. AMENDMENT.** Section 15.1-21-02.2 of the North Dakota Century Code is  
17          amended and reenacted as follows:

18          **15.1-21-02.2. High school graduation - Minimum requirements.**

19          Except as provided in section 15.1-21-02.3, the following twenty-two units of high school  
20          coursework constitute the minimum requirement for high school graduation:

- 21          1.    Four units of English language arts from a sequence that includes literature,  
22          composition, and speech;
- 23          2.    Three units of mathematics, which may include one unit of computer science approved  
24          by the superintendent of public instruction;
- 25          3.    Three units of science, consisting of:
  - 26          a.    (1)   One unit of biology;
  - 27          (2)   One unit of chemistry; and
  - 28          (3)   One unit of physics; or
  - 29          b.    (1)   One unit of biology;
  - 30          (2)   One unit of physical science; and
  - 31          (3)   One unit or two one-half units of any other science;

- 1           4.    Three units of social studies, including of which any one-half unit may be replaced by
- 2           Bible studies. Social studies units include:
- 3           a.    One unit of United States history;
- 4           b.    (1)  One-half unit of United States government and one-half unit of economics;
- 5                 or
- 6                 (2)  One unit of problems of democracy; and
- 7           c.    One unit or two one-half units of any other social studies, which may include
- 8                 civics, civilization, geography and history, multicultural studies, North Dakota
- 9                 studies, psychology, sociology, and world history;
- 10          5.    a.    One unit of physical education; or
- 11                 b.    One-half unit of physical education and one-half unit of health;
- 12          6.    Three units of:
- 13                 a.    Foreign languages;
- 14                 b.    Native American languages;
- 15                 c.    Fine arts; or
- 16                 d.    Career and technical education courses; and
- 17          7.    Any five additional units.
