1	A BILL for an Act to create and enact a new section to chapter 15.1-01 of the North Dakota					
2	Century Code, relating to the creation of the kindergarten through grade twelve education					
3	coordination council; to amend and reenact subsection 2 of section 28-32-01, and subsection 1					
4	of section 54-59-33 of the North Dakota Century Code, relating to the definition of administrative					
5	agency, and the statewide longitudinal data system committee; and to repeal sections 54-59-17					
6	and 54-59-18 of the North Dakota Century Code, relating to the educational technology council.					
7	BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:					
8	SECTION 1. A new section to chapter 15.1-01 of the North Dakota Century Code is created					
9	and enacted as follows:					
10	Kindergarten through grade twelve education coordination council.					
11	<u>1.</u>	The	state board of public school education shall oversee the creation and ongoing			
12		<u>ope</u>	eration of the kindergarten through grade twelve education coordination council.			
13	<u>2.</u>	The	e council consists of:			
14		<u>a.</u>	Three members of the legislative assembly, one member of the majority party			
15			from each chamber of the legislative assembly, selected by the respective			
16			majority leader of the chamber, and one member of the minority party selected			
17			through collaboration between the respective minority leaders of each chamber;			
18		<u>b.</u>	The governor or the governor's designee:			
19		<u>C.</u>	The superintendent of public instruction or the superintendent's designee;			
20		<u>d.</u>	The president of the state board for career and technical education or the			
21			president's designee;			
22		<u>e.</u>	The president of the board of the North Dakota council of educational leaders or			
23			the president's designee;			

The president of the board of North Dakota united or the president's designee;

1 The president of the board of the North Dakota school boards association or the 2 president's designee; 3 <u>h.</u> The president of the board of the North Dakota small organized schools or the 4 president's designee; 5 The president of the board of the North Dakota school counselor association or 6 the president's designee; and 7 The following gubernatorial appointees: 8 An individual representing the statewide longitudinal data system 9 committee; 10 (2) An individual representing a tribal school; 11 <u>(3)</u> An individual employed as a public school administrator; 12 (4) An individual employed as a public school principal; 13 (5)An individual employed as a public school teacher; 14 A director of a special education unit; and (6) 15 **(7)** A director of a regional education association. 16 The term of office for a member appointed by the governor is four years. The governor <u>3.</u> 17 may stagger the initial appointments to the council so no more than three members' 18 terms expire in any year. 19 The council shall select a presiding officer annually from among its members. <u>4.</u> 20 <u>5.</u> A member of the council who is a member of the legislative assembly is entitled to 21 receive per diem compensation at the rate provided under section 54-35-10 for each 22 day performing official duties of the council and to reimbursement for travel and 23 expenses as provided by law, to be paid by the legislative council. A member of the 24 council who is not a state employee is entitled to receive as compensation sixty-two 25 dollars and fifty cents per day and to reimbursement of expenses as provided by law 26 for state officers while attending meetings of the council, to be paid by the state board 27 of public school education. A state employee who is a member of the council is entitled 28 to receive that employee's regular salary and is entitled to reimbursement for mileage 29 and expenses, to be paid by the employing agency. 30 <u>6.</u> The council may hire an executive director. 31 7. The council shall:

1		<u>a.</u>	Assist in the implementation, dissemination, and communication of the statewide
2			strategic vision and evaluate progress toward meeting the identified goals and
3			strategies.
4		<u>b.</u>	Perform a continuous review of the effectiveness and efficiency of access and
5			delivery of education services and programs in the state.
6		<u>C.</u>	Identify opportunities for increased collaboration among state education entities
7			and stakeholders.
8		<u>d.</u>	Identify gaps or duplications in education services and programs and provide
9			recommendations for addressing those gaps or duplications.
10		<u>e.</u>	Study and evaluate new and emerging educational initiatives and trends and
11			provide recommendations for policy changes to state entities or the legislative
12			assembly if necessary.
13		<u>f.</u>	Support the implementation, dissemination, and communication of local or
14			regional educational initiatives and practices, including innovative education
15			programs, on a statewide level.
16		<u>g.</u>	Establish a one-stop communication and information hub to provide the public
17			and interested parties with seamless access to state entities that deliver
18			education services and programs.
19		<u>h.</u>	Develop and utilize subcommittees as needed.
20		<u>i.</u>	Seek advice and input from interested parties not appointed to the council as
21			needed.
22	<u>8.</u>	<u>The</u>	council shall meet at least four times per calendar year.
23	<u>9.</u>	<u>The</u>	council shall prepare and present an annual report of council activities to the state
