HB 1390 limits the amount the foundation aid formula can deduct for contribution from property tax. HB 1390 also limits the the increases in true and full value taxable property as well as the dollar amount a political subdivision levy.

Section 1 limits the contribution from property tax revenue in the foundation aid formula to the amount deducted the previous year. If the voters approve additional increase authority, the foundation aid formula will deduct the percentage increase approved by a majority of qualified electors.

Section 2 limits the increase in true and full value of taxable property to the true and full value of the previous year.

Section 3 limits the increase in property taxes levied in dollars to the amount the taxing district levied in the preceding year.

The foundation aid funding formula would not be able to increase the amount deducted for the contribution from property tax from the amount deducted in school year 2018-19. Restricting this increase would increase the appropriation for the integrated formula payment line by \$35,020,000 for the first biennium and \$74,189,213 for the 2021-23 biennium. See Attachment for details.

School districts levy authority would change as new taxable property in the district and as there are improvements to current property. The department does not collect enough data at this time to determine the fiscal impact for school districts.

If the qualified electors vote to increase the levy authority for school districts, the foundation aid formula would adjust its contribution from property tax to reflect the increase in levy authority. This could potentially decrease the fiscal impact of this bill.
