This bill provides consumers numerous significant rights regarding information collected or maintained by data brokers, etc. The Attorney General will be solely responsible for enforcement of the consumer rights.

The Attorney General will be solely responsible for enforcement of the consumer rights or other violations of the chapter and will need to review complaints, conduct investigations, and initiate legal action. The Attorney General will require one attorney and one paralegal to perform these additional duties. In addition, there will be significant investigation and litigation costs, including travel costs, deposition costs, expert consultants, and witness fees.

The Office of Attorney General is charged with handling investigations or legal actions regarding enforcement which will likely would be complicated and time-consuming, requiring an additional attorney and paralegal, including using existing Consumer Protection investigators. The enforcement also could be very technical requiring outside consultants or experts with subject area expertise. This legislation will result in consumer complaints and, in some instances, an investigation or legal action involving a data broker or other entity could result in significant expenses for travel, depositions, etc. It appears one attorney and one paralegal position are needed to handle this work. The 2019-21 biennium estimate is \$390,939 in salaries and \$317,890 in operating. The costs of expert witness fees and depositions is estimated to be \$200,000 (included in the operating expenses estimate). The 2021-23 biennium estimate is \$414,395 in salaries and \$338,438 in operating expenses.
