4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from other income, to the North Dakota racing commission for the purpose of defraying the expenses of the North Dakota racing commission, for the biennium beginning July 1, 2021, and ending June 30, 2023, as

10	SECTION 3. RACING COMMISSION FUNDING - LEGISLATIVE MANAGEMENT STUDY -				
11	RACING COMMISSION FUNDING. During the 2021-22 interim, the legislative management				
12	shall consider studying funding sources for the budget of the racing commission. The study				
13	must include consideration of the feasibility and desirability of changing the racing commission				
14	to a special funds only budget and the effect on general fund revenues. The legislative				

management shall report its findings and recommendations, together with any legislation

required to implement the recommendations, to the sixty-eighth legislative assembly.
