1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of

2 veterans' affairs; to provide for a report; and to provide an exemption.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
as may be necessary, are appropriated out of any moneys in the general fund in the state
treasury, not otherwise appropriated, and from special funds derived from federal funds and
other income, to the department of veterans' affairs for the purpose of defraying the expenses of
the department of veterans' affairs, for the biennium beginning July 1, 2021, and ending
June 30, 2023.

23 SECTION 3. EXEMPTION - POSTTRAUMATIC STRESS DISORDER SERVICE DOG

24 **PROGRAM.** The \$50,000 appropriated from the general fund for the posttraumatic stress

25 disorder service dog program in section 1 of chapter 25 of the 2019 Session Laws is not subject

to section 54-44.1-11 and any unspent funds from this program are available for the program

during the biennium beginning July 1, 2021, and ending June 30, 2023.
