6 SECTION 1. EMERGENCY COMMISSION AUTHORIZATION ADJUSTMENTS -

7 **APPROPRIATION.** The amounts identified in the emergency commission authorization column

below represent the federal coronavirus relief fund spending authority approved for each

agency or institution by the emergency commission and budget section under section

10 54-16-04.1 for the biennium ending June 30, 2021. The director of the office of management

and budget shall adjust the federal coronavirus relief fund spending authorization amount for

each agency and institution to the amounts shown in the appropriation column which are

LEGISLATIVE INTENT - STATE FISCAL RECOVERY FUND AND 16 CORONAVIRUS CAPITAL PROJECTS FUND. It is the intent of the sixty-seventh legislative 17 assembly that state fiscal recovery funds and any unexpended federal coronavirus capital 18 projects funds received through H.R. 1319 of the 117th Congress, also known as the federal 19 American Rescue Plan Act, be appropriated by the legislative assembly during future regular 20 and special legislative sessions and that funding for one-time initiatives and projects that 21 improve the well-being of the state's citizens be given consideration for use of this funding. 22 **SECTION 4. EXEMPTION.** The funding appropriated in section 1 of this Act is not subject to 23 the provisions of section 54-44.1-11 and may be continued into the biennium beginning July 1, 24 2021, and ending June 30, 2023. 25 SECTION 5. RETROACTIVE APPLICATION. Section 1 of this Act applies retroactively to 26 May 15, 2020.
