Engrossed HB 1281 creates a new income tax credit for taxpayers with dependents attending nonpublic or home schools.

Section 1 of engrossed HB 1281 creates a new income tax credit for individuals with dependents attending nonpublic or home schools. The credit is \$500 per student per year. If the credit exceeds the taxpayer's tax liability in the tax year in which the credit is first allowed, the excess may be carried over and used in the subsequent tax year.

The total enrollment in nonpublic and home schools in grades k through 12 is approximately 9,600 students. Therefore, the credit is estimated to be \$4.8 million per year, or \$9.6 million per biennium. The average tax liability would allow for two qualifying students per household to utilize this credit. Any unused credit can be carried forward to the next tax year.

If enacted, engrossed HB 1281 is expected to reduce state general fund revenues by an estimated -\$9.6 million for the 2021-23 biennium. (Note: this fiscal note assumes home schooling does not include pandemic-related distance learning.)
