SB 2319 redefines wells located within the boundaries of a reservation to include exterior wells with laterals that penetrate the reservation.

SB 2319 redefines wells located within the exterior boundaries of a reservation to include wells with a wellhead located outside the exterior boundaries of a reservation but containing horizontal laterals that penetrate the reservation. This will enable any new tribal oil and gas agreements entered into after the effective date of the bill to share revenue with the tribe from the affected wells drilled outside the reservation.

If enacted, SB 2319 may result in a new agreement between the State and Three Affiliated Tribes. If a new agreement with Three Affiliated Tribes occurs, the biennial fiscal impact is an expected reduction in oil and gas tax revenue totaling an estimated \$15.5 million, and a corresponding increase in tribal allocations of \$15.5 million.

The state's oil and gas tax revenue "buckets" expected to be reduced by the definition change include the legacy fund, common schools trust fund, foundation aid stabilization fund, resources trust fund, and the strategic investment and improvements fund. The counties, cities, and school districts' revenue is also expected to decrease, by an estimated \$2.4 million, collectively shown in 1B above.
