HB 1464 increases the motor and special fuels tax rates from \$.23 to \$.27 per gallon, in two annual increments of \$.02 each.

Section 1 of HB 1464 increases the motor vehicle fuels tax. Section 2 increases the special fuels tax. The tax rates are increased in two cent increments: from the current law rate of \$.23 to \$.25 per gallon in FY 22, and from \$.25 to \$.27 per gallon in FY 23.

If enacted, HB 1464 is expected to increase highway tax distribution fund revenues by a total of \$43.8 million in the 2021-23 biennium. Of this amount, \$27.5 million will be the DOT and Transit share, with the remainder for counties, cities, and townships, as shown above.
