

Current Program Status: According to the MISO3, there were 2,593 new teachers since 2014-15. Of those teachers, 1,275 were not in the NDTSS Mentoring Program. Approximately 51% of new teachers participated in the NDTSS. In order to fully fund the program, additional funding would be necessary to provide mentoring to the remaining 49% of new teachers.

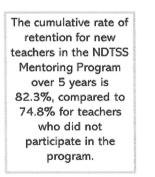

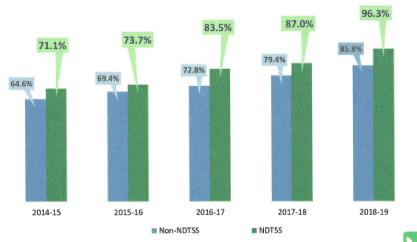
Demonstrated Results: Each year, the average rate of retention for NDTSS teachers since 2014-15 is higher than for teachers not mentored in the NDTSS and the ND Average retention rate.

■ Average rate of retention for NDTSS during the 2018-19 school year was 96.3% compared to 85.8% for teachers not mentored in the NDTSS.

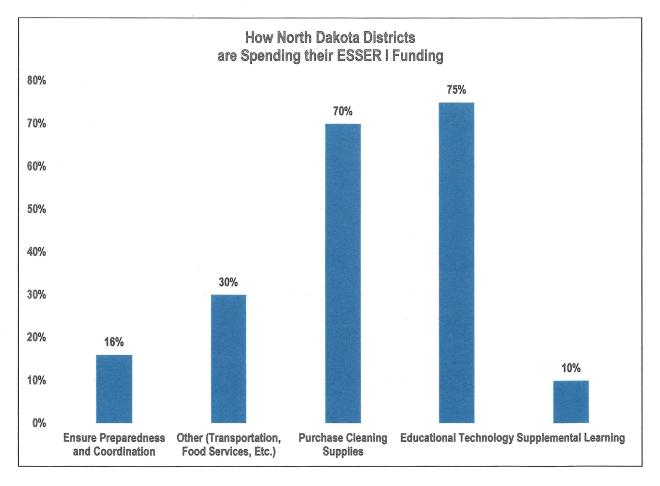
