DDS MISSION

To improve the quality of life for North Dakotans with disabilities who apply for or receive Social Security Administration disability benefits, by making timely, consistent and accurate disability determinations.



THE DISABILITY DETERMINATION SERVICES (DDS) PROGRAM



- 100% federally funded
- DDS staff make medical disability determinations using Social Security Administration (SSA) guidelines
- The Social Security disability program provides Social Security Disability Insurance (SSDI) and/ or Supplemental Security Income (SSI) benefits to persons with disabilities who are unable to work


DISABILITY DECISIONS



- The DDS processes disability determinations for the Social Security Administration for 3 main claim levels:
 - Initial claims
 - Reconsideration claims
 - Continuing Disability Reviews (CDR)
- The number of disability decisions that the DDS makes each year is determined by the Social Security Administration

COVID-19 IMPACTS

- The DDS was directed by the SSA to temporarily suspend some service delivery activities due to the pandemic
- Those activities were focused on avoiding certain adverse actions that would result in a reduction, suspension or termination of Social Security or Supplemental Security Income benefits.
- Safety considerations were also of chief concern, so we did not:
 - Schedule consultative examinations
 - Schedule in-person disability hearings


