1 A BILL for an Act to create and enact a new subdivision to subsection 2 of section 12-60-24, a
2 new section to chapter 16.1-01, sections 16.1-07-13.1 and 16.1-12-10, [a new section to chapter](#)
3 [16.1-13, section 44-02-03.1](#), and a new section to chapter 54-09 of the North Dakota Century
4 Code, relating to election administration; to amend and reenact subsection 1 of section

1 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

2 **SECTION 1.** A new subdivision to subsection 2 of section 12-60-24 of the North Dakota
3 Century Code is created and enacted as follows:

4 The secretary of state for employees with access to personally identifying
5 information of residents or businesses of the state or with access to elections
6 systems that are critical infrastructure under section 44-04-24.

7 **SECTION 2.** A new section to chapter 16.1-01 of the North Dakota Century Code is created
8 and enacted as follows:

9 **Definitions.**

10 For purposes of this title, unless the context otherwise requires, "candidate" means ~~an~~
11 individual who seeks nomination for election or election to public office, and includes:

- 12 1. An individual holding public office;
- 13 2. An individual who publicly has declared that individual's candidacy for nomination for
14 election or election to public office or has filed or accepted a nomination for public
15 office;
- 16 3. An individual who has formed a campaign or other committee for that individual's
17 candidacy for public office;
- 18 4. An individual who has circulated a nominating petition to have that individual's name
19 placed on the ballot; and
- 20 5. An individual who, in any manner, has solicited or received a contribution for that
21 individual's candidacy for public office, whether before or after the election for that
22 office.

23 **SECTION 3. AMENDMENT.** Subsection 1 of section 16.1-01-01 of the North Dakota
24 Century Code is amended and reenacted as follows:

- 25 1. The secretary of state ~~must be~~ is, ex officio, supervisor of elections and may employ
26 additional personnel to administer this title. The secretary of state shall supervise the
27 conduct of elections and in that supervisory capacity has, in addition to other powers
28 conferred by law, the power to examine upon the secretary of state's request or the
29 request of any election official, any election ballot or other material, ~~electronic~~ electronic voting
30 system ~~or counting machine~~ authorized by chapter 16.1-06, or device used in
31 connection with any election, for the purpose of determining sufficient compliance with

1 the law and established criteria and standards adopted by the secretary of state
2 according to section 16.1-06-26. The secretary of state, upon determining that any
3 ballot or other material, ~~electronic voting system or counting machine~~, or device is not
4 in sufficient compliance with the law or established criteria and standards, shall direct
5 the proper changes to be made, and in the case of ~~electronic voting systems and~~
6 ~~counting machines~~, may decertify the ~~electronic voting systems and counting~~
7 ~~machines~~ according to the rules adopted under section 16.1-06-26.

8 **SECTION 4. AMENDMENT.** Section 16.1-01-03 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **16.1-01-03. Opening and closing of the polls.**

11 The polls at all primary, general, and special elections must be opened at nine a.m. or
12 earlier, but not earlier than seven a.m., as designated for any precinct by resolution of the
13 governing body of the city or county in which the precinct is located. The polls must remain
14 open continuously until seven p.m. or ~~such~~ later hour, not later than nine p.m., as may be
15 designated for a precinct by resolution of the governing body of the city or county in which the
16 precinct is located. All electors standing in line to vote at the time the polls are set to close must
17 be allowed to vote, but electors arriving after closing time may not be allowed to vote. A voter
18 may take up to thirty minutes to mark and cast the ballot after receiving the ballot from the
19 election judge. After the polls close, the election board may shall generate the report of the vote
20 totals not later than thirty minutes after the last elector in line at the closing time received a
21 ballot. An elector remaining in the polling place after the thirty minutes have expired who has
22 not completed marking the ballot must be offered the choice of casting the ballot as marked or
23 continuing to mark the ballot. If the elector chooses to continue marking the ballot, the ballot
24 selections must be excluded from the report of the vote totals generated by the election board
25 but must be forwarded by the election board to the canvassing board and added to the final
26 tally. The secretary of state shall develop uniform, mandatory procedures for election boards to
27 ensure the secrecy of each elector's ballot. The election officers present are responsible for
28 determining who arrived in time to vote, and the election officers shall establish appropriate
29 procedures for making that determination. All determinations required to be made pursuant to
30 this section relating to polling hours must be made, and the county auditor notified of ~~them~~the
31 determinations, no later than thirty days ~~prior to~~before an election.

1 **SECTION 5. AMENDMENT.** Section 16.1-01-05.1 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **16.1-01-05.1. Voter lists - Addition or transfer of names.**

4 Through the use of the central voter file provided for in chapter 16.1-02, the secretary of
5 state shall establish a procedure by which a county auditor may transfer ~~a person's an~~
6 individual's name from the voter list of one precinct to the voter list of another precinct in the
7 state if ~~that person~~the individual establishes a new residence, and by which ~~a person an~~
8 individual who establishes residence in the state may have ~~that person's~~the individual's name
9 placed on the voter list in the appropriate precinct. The procedure provided for in this section
10 may not be used to require the registration of electors.

11 **SECTION 6. AMENDMENT.** Section 16.1-01-06 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **16.1-01-06. Highest number of votes elects.**

14 Unless otherwise expressly provided by the laws of this state, in all elections for the choice
15 of any officer, the ~~person~~individual receiving the highest number of votes for any office ~~must~~
16 ~~be~~is deemed ~~to have been~~ elected to that office.

17 **SECTION 7. AMENDMENT.** Section 16.1-01-07 of the North Dakota Century Code is
18 amended and reenacted as follows:

19 **16.1-01-07. Constitutional amendments and other questions to be advertised -**
20 **Notification by secretary of state - Manner of publishing.**

21 ~~Whenever~~If a proposed constitutional amendment or other question is to be submitted to
22 the people of the state for popular vote, the secretary of state shall, ~~not less than fifty-five days~~
23 ~~before the election,~~ certify the amendment or other question to each county auditor not less
24 than fifty-five days before the election, and each auditor shall cause notice ~~thereof~~of the
25 question to be included in the notice required by section 16.1-13-05. Questions to be submitted
26 to the people of a particular county must be advertised in the same manner.

27 ~~The~~At the same time the secretary of state certifies notice to the county auditors of the
28 submission of a constitutional amendment or other question, the secretary of state shall, ~~at the~~
29 ~~same time the secretary of state certifies notice to the county auditors of the submission of a~~
30 ~~constitutional amendment or other question,~~ certify the ballot form for ~~such~~the questions. The
31 ballot form must conform to the provisions of section 16.1-06-09 and must be used by all county

1 ~~auditors in preparing to prepare~~ ballots for submission to the electorate of each county and in-
2 ~~the preparation of to prepare~~ sample ballots. Any requirements in this title that a sample ballot
3 ~~be published will be met by the~~The publication of either the paper ballot or the ballot as it will
4 appear to ~~persons~~individuals using an ~~electronic~~a voting system device, depending-
5 ~~upon whichever corresponds to~~ the method of voting used in the area involved, will satisfy any
6 requirement in this title for a sample ballot to be published. Absentee voter ballots may not be
7 considered in determining which method of voting is used in an area. If both paper ballots and
8 electronic voting system ballots are used in an area, both forms must be published as sample
9 ballots to meet publication and notice requirements. For two consecutive weeks before the
10 sample ballot is published, an analysis of any constitutional amendment, initiated measure, or
11 referred measure, written by the secretary of state after consultation with the attorney general,
12 must be published in columns to enable the electors to become familiar with the effect of the
13 proposed constitutional amendment or initiated or referred measure.

14 **SECTION 8. AMENDMENT.** Section 16.1-01-08 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **16.1-01-08. Correcting errors on ballots - Requiring performance of duty - Correcting**
17 **or prosecuting wrongful performance.**

- 18 1. The secretary of state shall ~~thoroughly~~ investigate thoroughly, when the matter comes
19 to the secretary of state's attention, any of the following:
- 20 ~~1.~~ a. Any error or omission ~~which that~~ has occurred or is about to occur in the placing
21 of any name on an official election ballot; however a ~~question~~ **question** **factual dispute**
22 regarding a candidate's residency may be resolved only by a court order.
- 23 ~~2.~~ b. Any error ~~which that~~ has been or is about to be committed in printing the ballot.
- 24 ~~3.~~ c. Any wrongful act ~~which that~~ has been or is about to be done by any judge or
25 election clerk, county auditor, canvassing board, a canvassing board member, or
26 any other ~~person~~individual charged with any duty concerning the election.
- 27 ~~4.~~ d. Any neglect of duty which has occurred or is about to occur.
- 28 2. If required, the secretary of state shall order the officer or ~~person~~individual charged
29 with ~~such the~~ error, wrong, or neglect to correct the error, desist from the wrongful act,
30 or perform any required duty. The secretary of state may call upon any county auditor
31 for aid in ~~investigation and correction of~~ investigating and correcting the problem. The

1 secretary of state shall cause any ~~person~~individual who violates the secretary of
2 state's order to be prosecuted; if the violation constitutes an offense pursuant to this
3 chapter. If the administrative remedies fail to correct the problem, or if the secretary of
4 state refuses to act, any ~~person~~individual may petition the supreme court, or the
5 district court of the relevant county ~~where~~if the election of a county officer is involved,
6 for an order compelling the correction of the error, wrong, neglect, or act.

7 **SECTION 9. AMENDMENT.** Subsection 5 of section 16.1-01-09 of the North Dakota
8 Century Code is amended and reenacted as follows:

9 5. When signed petitions are delivered to the secretary of state, the chairperson of the
10 sponsoring committee shall submit to the secretary of state an affidavit stating that to
11 the best of that individual's knowledge, the petitions contain at least the required
12 number of signatures. The chairperson also shall submit a complete list of petition
13 circulators which must include each circulator's full name and residential address. The
14 residential address must be in this state and identify the circulator's street address,
15 city, and zip code. Upon submission of the petitions to the secretary of state, the
16 petitions are considered filed and may not be returned to the sponsoring committee for
17 the purpose of continuing the circulation process or resubmitting the petitions at a later
18 time. An elector's name may not be removed by the elector from a petition that has
19 been submitted to and received by the secretary of state.

20 **SECTION 10. AMENDMENT.** Subsection 7 of section 16.1-01-09.1 of the North Dakota
21 Century Code is amended and reenacted as follows:

22 7. When recall petitions are delivered to the secretary of state or other filing officer with
23 whom a petition for nomination to the office in question is filed, the chairman of the
24 sponsoring committee shall submit to the secretary of state or other filing officer an
25 affidavit stating that to the best of that individual's knowledge, the petitions contain at
26 least the required number of signatures. The chairperson also shall submit a complete
27 list of petition circulators which must include each circulator's full name and residential
28 address. The residential address must be in this state and identify the circulator's
29 street address, city, and zip code. Upon submission of the petitions to the appropriate
30 filing officer, the petitions are considered filed and may not be returned to the chairman
31 of the sponsoring committee for the purpose of continuing the circulation process or

1 resubmitting the petitions at a later time. An elector's name may not be removed by
2 the elector from a recall petition that has been submitted to and received by the
3 appropriate filing officer.

4 **SECTION 11. AMENDMENT.** Section 16.1-01-12 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **16.1-01-12. Election offenses - Penalty.**

- 7 1. It is unlawful for an individual, measure committee as described in section
8 16.1-08.1-01, or other organization to:
- 9 a. Fraudulently alter another individual's ballot or substitute one ballot for another,
10 or to otherwise defraud a voter of that voter's vote.
 - 11 b. Obstruct a qualified elector on the way to a polling place.
 - 12 c. Vote more than once in any election.
 - 13 d. Knowingly vote in the wrong election precinct or district.
 - 14 e. Disobey the lawful command of an election officer as defined in chapter 16.1-05.
 - 15 f. Knowingly exclude a qualified elector from voting or knowingly allow an
16 unqualified ~~person~~individual to vote.
 - 17 g. Knowingly vote when not qualified to do so.
 - 18 h. Sign an initiative, referendum, recall, or any other election petition when not
19 qualified to do so.
 - 20 i. Circulate an initiative, referendum, recall, or any other election petition not in its
21 entirety or ~~circulate such a petition~~ when unqualified to do so.
 - 22 j. Pay or offer to pay any individual, measure committee, or other organization, or
23 receive payment or agree to receive payment, on a basis related to the number
24 of signatures obtained for circulating an initiative, referendum, or recall petition.
25 This subsection does not prohibit the payment of salary and expenses for
26 circulation of the petition on a basis not related to the number of signatures
27 obtained, as long as the circulators file ~~their~~the intent to remunerate ~~prior~~
28 ~~to~~before submitting the petitions and, in the case of initiative and referendum
29 petitions, fully disclose all contributions received pursuant to chapter 16.1-08.1 to
30 the secretary of state upon submission of the petitions. The disclosure of
31 contributions received under this section does not affect the requirement to file a

- 1 pre-election report by individuals or organizations soliciting or accepting
2 contributions for the purpose of aiding or opposing the circulation or passage of a
3 statewide initiative or referendum petition or measure placed upon a statewide
4 ballot by action of the legislative assembly under chapter 16.1-08.1. Any
5 signature obtained in violation of this subdivision is void and may not be counted.
- 6 k. Willfully fail to perform any duty of an election officer after having accepted the
7 responsibility of being an election officer by taking the oath as prescribed in this
8 title.
- 9 l. Willfully violate any rule adopted by the secretary of state pursuant to this title.
- 10 m. Willfully make any false canvass of votes, or make, sign, publish, or deliver any
11 false return of an election, knowing the ~~same~~canvass or return to be false; or
12 willfully deface, destroy, or conceal any statement or certificate entrusted to the
13 individual's or organization's care.
- 14 n. Destroy ballots, ballot boxes, election lists, or other election supplies except as
15 provided by law, or negatively impact the confidentiality, integrity, or availability of
16 any system used for voting.
- 17 o. Sign a name other than that individual's own name to an initiative, referendum,
18 recall, or any other election petition.
- 19 2. a. A violation of subdivisions b, e, f, or h through l of subsection 1 is a class A
20 misdemeanor.
- 21 b. A violation of subdivisions a, c, d, g, or m of subsection 1 is a class C felony.
- 22 c. A violation of subdivision n of subsection 1 ~~occurring after an election but before~~
23 ~~the final canvass, or during an election,~~ is a class C felony, ~~and in other cases is~~
24 ~~a class A misdemeanor.~~
- 25 d. A violation of subdivision o of subsection 1 is a class A misdemeanor if an
26 individual signs one or two names other than the individual's own name to a
27 petition and is a class C felony if an individual signs more than two names other
28 than the individual's own name to a petition.
- 29 e. An organization, as defined in section 12.1-03-04, that violates this section is
30 subject to the organizational fines in section 12.1-32-01.1. The court in which the
31 conviction is entered shall notify the secretary of state of the conviction and shall

1 order the secretary of state to revoke the certificate of authority of any convicted
2 organization or limited liability company. The organization may not reapply to the
3 secretary of state for authorization to do business under any name for one year
4 upon conviction of a class A misdemeanor and for five years upon conviction of a
5 class C felony under this section.

6 f. An individual who is a member of an organization may be convicted of a violation
7 as an accomplice under section 12.1-03-01.

8 3. Every act ~~which by this chapter is made~~this chapter makes criminal when committed
9 with reference to the election of a candidate is equally criminal when committed with
10 reference to the determination of a question submitted to qualified electors to be
11 decided by votes cast at an election.

12 **SECTION 12. AMENDMENT.** Section 16.1-01-16 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **16.1-01-16. Secretary of state to establish a uniform state-based administrative**
15 **complaint procedure.**

16 The secretary of state shall establish a uniform state-based administrative complaint
17 procedure to remedy grievances according to section 402 of the Help America Vote Act of 2002
18 [Pub. L. 107-252; 116 Stat. 1666; 42 U.S.C. 15512]. The complaint procedure must be uniform
19 and nondiscriminatory and address complaints of violations of any provision of title III of the
20 Help America Vote Act of 2002, including a violation that has occurred, is occurring, or is about
21 to occur. A complaint filed under the complaint procedure must be in writing; and notarized, and
22 be signed and sworn by the ~~person~~individual filing the complaint. The secretary of state is-
23 ~~authorized to~~may consolidate complaints. At the request of a complainant, the secretary of state
24 shall establish a procedure for providing a review on the record. If the secretary of state
25 determines there is a violation of a provision of title III of the Help America Vote Act of 2002
26 [Pub. L. 107-252; 116 Stat. 1666; 42 U.S.C. 15481-15502], the secretary of state shall
27 determine and provide an appropriate remedy. If the secretary of state determines ~~that~~ a
28 violation of title III of the Help America Vote Act of 2002 has not occurred, the secretary of state
29 shall dismiss the complaint and publish the results of the review. The secretary of state shall
30 make a final determination with respect to a complaint within ninety days of the date the
31 complaint is filed with the secretary of state, unless the complainant consents to a longer period

1 of time for the secretary of state to make a determination. If the secretary of state fails to meet
2 the ninety-day deadline for determining a complaint, the complaint must be resolved within sixty
3 days under an alternative dispute resolution procedure.

4 **SECTION 13. AMENDMENT.** Section 16.1-01-17 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **16.1-01-17. Estimated fiscal impact of an initiated or referred measure.**

7 ~~At least ninety days before a statewide election at which~~As soon as practicable after the
8 secretary of state approves an initiated or referred measure ~~will be voted upon for the ballot~~, the
9 legislative council shall coordinate the determination of the estimated fiscal impact of the
10 initiated or referred measure. Upon notification from the secretary of state that signed petitions
11 have been submitted for placement of an initiated or referred measure on the ballot, the
12 legislative management shall hold hearings, receive public testimony, and gather information on
13 the estimated fiscal impact of the measure. Each agency, institution, or department shall provide
14 information requested in the format and time frame prescribed by the legislative council for
15 identifying the estimated fiscal impact of the measure. At least thirty days before the public vote
16 on the measure, the legislative council shall submit a statement of the estimated fiscal impact of
17 the measure to the secretary of state. Upon receipt, the secretary of state shall include a notice
18 within the analysis required by section 16.1-01-07 specifying where copies of the statement of
19 the estimated fiscal impact can be obtained. Within thirty days of the close of the first complete
20 fiscal year after the effective date of an initiated or referred measure approved by the voters, the
21 agencies, institutions, or departments that provided the estimates of the fiscal impact of the
22 measure to the legislative council under this section shall submit a report to the legislative
23 council on the actual fiscal impact for the first complete fiscal year resulting from provisions of
24 the initiated or referred measure and a comparison to the estimates provided to the legislative
25 council under this section, and the legislative council shall issue a report of the actual fiscal
26 impact of the initiated or referred measure.

27 **SECTION 14. AMENDMENT.** Section 16.1-02-01 of the North Dakota Century Code is
28 amended and reenacted as follows:

29 **16.1-02-01. Permanent central voter file.**

30 A permanent, centralized electronic database of voters, to be known as the central voter
31 file, is established with the offices of the secretary of state and county auditors linked together

1 by a centralized statewide system. The county auditor is chief custodian of the central voter file
2 records in each county. The secretary of state shall maintain the central voter file and provide
3 training and documentation that users who have been granted access to the system shall
4 follow. The central voter file must be accessible by the secretary of state and all county auditors
5 for purposes of preventing and determining voter fraud, making changes and updates, and
6 generating information, including pollbooks, reports, inquiries, forms, and voter lists.

7 **SECTION 15. AMENDMENT.** Section 16.1-02-02 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **16.1-02-02. Costs of creating and maintaining a central voter file.**

10 ~~The creation of the central voter file and its maintenance through June 30, 2011, must be~~
11 ~~paid for with funds from the state's election fund, provided the election fund contains adequate~~
12 ~~funding to create and maintain the central voter file. The creation of the central voter file and its~~
13 ~~maintenance through June 30, 2011, may not be paid for from funds in the secretary of state's~~
14 ~~budget, the state's general fund, or from county funds. Beginning July 1, 2011, the~~The offices
15 required to perform the functions and duties of this chapter shall bear the costs incurred in
16 performing those duties, and the secretary of state shall pay the costs of operating and
17 maintaining the central voter file. As used in this section, costs of maintaining the central voter
18 file mean costs of annual software licenses, ~~hosting costs for the software in the state data-~~
19 ~~center~~hosting, costs of necessary enhancements to the software, database updates, and the
20 costs for implementing the duties and responsibilities of the secretary of state's office relating to
21 the central voter file.

22 **SECTION 16. AMENDMENT.** Section 16.1-02-05 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **16.1-02-05. Entry of new voters into the central voter file - Query of the central voter**
25 **file for double voting - Postelection verification.**

26 1. ~~Within forty-five days~~Before the meeting of the county canvassing board following an
27 election, the county auditor shall enter the name and required information of each
28 individual who voted at the last election who is not already contained in the central
29 voter file and update any required information requested and obtained at the last
30 election for any individual contained in the central voter file.

- 1 2. The secretary of state, with the assistance of the county auditors, ~~within eighty-five-~~
2 ~~days following an election~~before the meeting of the state canvassing board, shall

5 auditor and state's attorney in each affected county for further investigation.
- 6 3. Upon return of any nonforwardable mail from an election official, the county auditor
7 shall ascertain the name and address of that individual. If the individual is no longer at
8 the address recorded in the central voter file, the county auditor shall transfer the voter
9 to the correct precinct in the central voter file or notify the county of the voter's new
10 residence so the voter record can be transferred to the correct county. If a notice
11 mailed at least sixty days after the return of the first nonforwardable mail is also
12 returned by the postal service, the county auditor shall designate the individual as
13 "inactive" in the central voter file.

14 **SECTION 17. AMENDMENT.** Section 16.1-02-06 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **16.1-02-06. Reporting deceased individuals and changes of names - Changes to**
17 **records in the central voter file.**

- 18 1. The state health officer shall provide for the regular reporting to the secretary of state
19 the name, address, date of birth, and county of residence, if available, of each
20 individual eighteen years of age or older who has died while maintaining residence in
21 this state since the last report. Within thirty days after receiving a report, the secretary
22 of state shall designate each individual included in the report as "deceased" in the
23 central voter file. ~~The secretary of state shall prepare and distribute a list of individuals-~~
24 ~~designated as "deceased" to each county auditor.~~
- 25 2. The state health officer shall provide for the regular reporting to the secretary of state
26 the name, address, date of birth, and county of residence, if available, of each
27 individual eighteen years of age or older whose name was changed by marriage since
28 the last report. ~~The secretary of state shall prepare and distribute a list of those-~~
29 ~~individuals to each county auditor.~~
- 30 3. After receiving notice of death of an individual who has died outside the county, the
31 county auditor shall designate that individual as "deceased" in the central voter file.

1 Notice must be in the form of a printed obituary or a written statement signed by an
2 individual having knowledge of the death of the individual.

3 **SECTION 18. AMENDMENT.** Section 16.1-02-07 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **16.1-02-07. Reporting changes of names - Changes to records in the central voter file.**

6 The state court administrator shall provide for the regular reporting to the secretary of state
7 the name, address, date of birth, and county of residence, if available, of each individual
8 eighteen years of age or older whose name was changed by divorce or any order or decree of
9 the court since the last report. ~~The secretary of state shall prepare and distribute a list of those~~
10 ~~individuals to each county auditor.~~ Any individual who has obtained a protection order under
11 section 14-07.1-03 or who is protected by a disorderly conduct restraining order under section
12 12.1-31.2-01 must be listed in the central voter file with a "secured active" designation. A
13 "secured active" designation means a record maintained as an active voter for pollbook
14 purposes, but otherwise is an exempt record. The state court administrator or the bureau of
15 criminal investigation shall make available upon request of the secretary of state the name of
16 each individual who has obtained such an order.

17 **SECTION 19. AMENDMENT.** Section 16.1-02-10 of the North Dakota Century Code is
18 amended and reenacted as follows:

19 **16.1-02-10. Posting voting history - Failure to vote - Individuals designated inactive.**

20 ~~Within seventy-five days after each election~~Before the end of the contest period allowed

22 who voted in the election. After the close of each even-numbered calendar year, the secretary
23 of state shall determine if any individual has not voted during the preceding four years and shall
24 change the status of each such individual to "inactive" in the central voter file. ~~The secretary of~~
25 ~~state shall prepare a report to each county auditor which contains the name of each individual~~
26 ~~who has been designated as "inactive" in the central voter file.~~ Although not counted in an
27 election, a late absentee ballot from an individual may not be used to designate an individual as
28 "inactive" in the central voter file.

29 **SECTION 20. AMENDMENT.** Section 16.1-02-11 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **16.1-02-11. Secretary of state ~~to~~may adopt rules for the purpose of maintaining the**
2 **central voter file.**

3 The secretary of state ~~shall~~may adopt rules and procedures according to subsection 3 of
4 section 16.1-01-01 ~~for the purpose of implementing~~to implement this chapter and ~~for updating~~
5 ~~and maintaining~~to update and maintain the central voter file. The rules ~~must~~may:

- 6 1. Provide for the establishment and maintenance of a central voter file.
- 7 2. Provide for the generation and assignment of a unique identifier to each individual
8 contained in the central voter file.
- 9 3. Provide procedures for entering data into the central voter file.
- 10 4. Provide for any additional information to be requested of and obtained from an
11 individual which is to be maintained in the central voter file, not already provided by
12 law, but necessary for the proper administration of the central voter file.
- 13 5. Provide for the exchange of records maintained by the appropriate state and county
14 agencies and officials for receiving regular reports regarding individuals and records of
15 individuals contained in the central voter file.
- 16 6. Allow each county auditor and the secretary of state to add, modify, and delete
17 information from the central voter file to ensure accurate and up-to-date records.
- 18 7. Allow each county auditor and the secretary of state to have access to the central
19 voter file for review, search, and inquiry capabilities.
- 20 8. Provide security and protection of all information contained in the central voter file and
21 ~~to~~ ensure that unauthorized access and entry is prohibited.
- 22 9. Provide a system for each county to identify the precinct to which an individual should
23 be assigned for voting purposes.

24 **SECTION 21. AMENDMENT.** Section 16.1-02-13 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **16.1-02-13. Information contained in pollbooks generated from the central voter file.**

27 The county auditor shall generate a pollbook for each precinct in the county from the central
28 voter file by the day before an election. With the exception of a record designated "secured
29 active" and the voter's birth date and driver's license or nondriver identification card number
30 issued by the department of transportation, which are exempt records, the precinct pollbooks
31 are open records under section 44-04-18. When providing access to or a copy of a pollbook, the

1 election official administering the election shall redact from the pollbook any voter records
2 designated as secured active along with the voter's date of birth and identification numbers
3 listed on the paper pollbook used in an election. If an electronic pollbook is used, the election
4 official, upon request for a copy of the pollbook, shall generate a list including the allowable
5 information detailed in this section for the individuals who voted in the election. The list provided
6 from an electronic pollbook may be requested by precinct or county. The secretary of state shall
7 prescribe procedures for generating pollbooks and for transporting the pollbooks to the election-
8 judgespoll clerks for use on election day. ~~Pollbooks~~Electronic pollbooks may have a secure
9 connection from the polling place to the data maintained in the central voter file to ensure the
10 integrity of the election. Each pollbook generated from the central voter file must contain the
11 following information for each individual contained therein in the pollbook:

- 12 1. The complete legal name of the individual.
- 13 2. The complete residential address of the individual.
- 14 3. The complete mailing address of the individual, if different from the individual's
15 residential address.
- 16 4. The unique identifier generated and assigned to the individual.
- 17 5. The county, legislative district, city or township, school district, county commissioner
18 district, if applicable, precinct name, and precinct number in which the individual
19 resides. A ballot-style code identifying this information may be used in place of the
20 information required by this subsection.
- 21 6. Any other information requested of and obtained from the individual deemed
22 necessary by the secretary of state for the proper administration of the pollbook.

23 **SECTION 22. AMENDMENT.** Subsection 2 of section 16.1-05-01 of the North Dakota
24 Century Code is amended and reenacted as follows:

- 25 2. The election judges must be appointed in the following manner:
 - 26 a. Except as provided in subdivision b:
 - 27 (1) The election judges for each polling place must be appointed in writing by
28 the district chairs representing the two parties that cast the largest number
29 of votes in the state at the last general election. In polling places in which
30 over one thousand votes are cast in any election, the county auditor may
31 request each district party chair to appoint an additional election judge.

1 (2) The district party chair shall notify the county auditor of the counties in which
2 the precincts are located of the appointment of the election judges at least
3 forty days before the primary, general, or special election. If this notice is not
4 received within the time specified in this section, the county auditor shall
5 appoint the judges and provide notice of the appointment to the district party
6 chair. If the county auditor has exhausted all practicable means to select
7 judges from within the boundaries of the precincts within the polling place
8 and vacancies still remain, the county auditor may select election judges
9 who reside outside of the voting precinct but who reside within the polling
10 place's legislative districts. If vacancies still remain, the county auditor may
11 select election judges who reside outside of the legislative districts but who
12 reside within the county.

13 b. For special elections involving only no-party offices, the election official
14 responsible for the administration of the election, with the approval of the majority
15 of the members of the applicable governing body, shall appoint the election
16 judges for each polling place.

17 **SECTION 23. AMENDMENT.** Section 16.1-06-04 of the North Dakota Century Code is
18 amended and reenacted as follows:

- 21 4. a. Be printed on uniform quality and color of paper in an ink color suitable to make

- 24 2. b. Be of sufficient length to contain the names of all candidates to be voted for at
25 that election.
- 26 3. c. Have the language "Vote for no more than _____ name (or names)" placed
27 immediately under the name of each office.
- 28 4. d. Have printed ~~thereon on the ballot~~ "To vote for the candidate of your choice, ~~you~~
29 ~~must~~ darken the oval next to the name of that candidate. To vote for a person
30 whose name is not printed on the ballot, ~~you must~~ darken the oval next to the
31 blank line provided and write that person's name on the blank line."

1 5. e. Have printed on the ballot "The word 'endorsed' following or under a candidate's
2 name means the candidate was endorsed by the political party indicated. The
3 word 'petition' following or under a candidate's name means the candidate
4 circulated a petition for signatures to be included on the ballot."

5 f. Leave sufficient space for each office to write a name, or names, as the case
6 may be, in lieu of those printed on the ballot.

7 6. g. ~~Immediately~~Have an oval printed preceding and on the same line as the name of
8 each candidate ~~must be printed an oval in~~ which the voter is to darken to mark
9 the voter's choice ~~by darkening the oval next to the name of the candidate~~
10 chosen.

11 7. h. Provide text boxes at the bottom of the first side of the ballot. The text box at the
12 bottom of the first column is to contain the words "Official Ballot, the name of the
13 county, the name or number of the precinct, and the date of the election". The
14 text box is to contain the words "All ballots, other than those used to vote
15 absentee, must first be initialed by appropriate election officials in order to be
16 counted". The text box at the bottom of the third column is to contain the word
17 "initials" preceded by a blank line where the judge or inspector shall initial the
18 ballot.

19 ~~Any precinct that uses an electronic counting machine may require the use of a particular~~
20 ~~writing instrument to mark the ballot so the ballots may be properly counted.~~

21 2. The ballot must contain the names of all candidates, the contents of measures as
22 required by section 16.1-06-09, and the statements of questions to be submitted to the
23 voters. The ballot must be arranged in a manner and form approximating as far as
24 possible the requirements of this section.

25 **SECTION 24. AMENDMENT.** Section 16.1-06-11 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **16.1-06-11. ~~Electronic voting~~Voting systems authorized.**

28 ~~The use of electronic voting~~Voting systems may be used in accordance with the provisions
29 of this chapter ~~is hereby authorized in any election precinct upon finding and declaration by~~
30 ~~resolution of the city governing body, and also of the board of county commissioners of the~~
31 ~~county in which such election precinct is located, that such use is advisable or necessary in that~~

1 ~~precinct. Thereafter, a system or~~ Voting systems may be procured, ~~on a temporary or~~
2 ~~permanent basis, under terms and conditions, including assumption and division of cost of~~

18 tabulating paper ballot, recorded by optical scan reader, containing the names of
19 offices and candidates and the questions to be voted on, which is used in conjunction
20 with the marking device and on which votes may be recorded. For direct recording
21 electronic voting systems, ballot means the ballot display provided by electro-optical
22 devices showing the names and candidates and the questions to be voted on that
23 allows a voter to directly enter choices into electronic storage with the use of a
24 touchscreen or other data entry device. The term includes the digital image of a
25 marked ballot captured by a voting system.
- 26 2. "Ballot marking device" means a device for marking ballots with ink or other
27 substance, or any other method for recording votes on ballots such that the votes may
28 be tabulated and counted by tabulation.
- 29 3. ~~"Counting center" means the~~ a ~~location or locations~~ designated by the county auditor
30 for the ~~automatic tabulating and counting of ballots and tabulation of votes from the~~
31 ballots.

- 1 4. ~~"Direct recording electronic voting system~~Digital scan" means a voting system that
2 records votes by means of a ballot display provided by electro-optical devices that
3 allows a voter to directly enter choices into electronic storage with the use of a
4 touchscreen or other data entry device. An alphabetic keyboard may be employed as
5 an entry device to facilitate voting for write-in candidates. A voter's choices are stored
6 in the direct recording electronic voting system's internal memory devices and added
7 to the choices of all other votersprocedure in which votes cast on a paper ballot are
8 tabulated by examining marks made in voting response locations on the ballot and an
9 image of the ballot is captured and retained.
- 10 5. ~~"Electronic voting~~Voting system" means ~~a~~the system, or the combination of electronic
11 voting systems and devices authorized under this chapter, that may employ a marking
12 device in conjunction with ballots or the use of a touchscreen or other data entry
13 device and automatic tabulating equipment for the recording, tabulating, and counting
14 of votes in an election.
- 15 6. ~~"Electronic voting system device"~~ means a single unit of an electronic voting system.
- 16 7. ~~"Marking device"~~ means a device for marking ballots with ink or other substance, or
17 any other method for recording votes on ballots in a manner that the votes may be
18 tabulated and counted by automatic tabulating equipment.
- 19 8. ~~"Optical scan"~~ means a procedure in which votes cast on a paper ballot are tabulated
20 by means of examining marks made in voting response locations on the ballot with an
21 optical reader and devices authorized under this chapter which may employ a ballot
22 marking device with use of a touchscreen or other data entry device to record and
23 count votes in an election.

24 **SECTION 26. AMENDMENT.** Section 16.1-06-14 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **16.1-06-14. Requirements for electronic voting systems.**

27 Any electronic voting system used in an election in this state must:

- 28 1. Provide facilities for voting for nominated candidates, for persons not in nomination,
29 and upon questions or measures submitted to the voters.
- 30 2. Permit each voter to vote for as many persons for any office as the voter is entitled to
31 vote for, and must allow each voter to vote in primary elections for candidates for

- 1 nomination by the political party of the voter's choice, but ~~the system~~ must preclude
2 each voter from voting for more persons for any office than the voter is entitled to vote
3 for, from voting more than once for the same candidate or upon the same measure or
4 question submitted to the voters, or voting the ballot of more than one political party in
5 any primary election.
- 6 3. Permit each voter, insofar as is possible, by the replacement of spoiled ballots, to
7 change the voter's vote for any candidate, or upon any measure or question submitted
8 to the voters, up to the time the voter begins the final operation to register the voter's
9 vote.
- 10 4. Permit and require ~~voting in absolute~~ secrecy while voting, and must be so-
11 constructed and controlled ~~that so~~ no ~~person~~ other individual can see or know for whom
12 ~~any other~~ an elector has voted or is voting, except ~~a voter whom the person has~~
13 ~~assisted or is~~ an individual assisting in ~~voting, marking the ballot at the request of the~~
14 elector as prescribed by law, and ~~that no person may~~ individual is able to see or know
15 the number of votes registered for any candidate ~~or tamper with any mechanism~~ while
16 the polls are open.
- 17 5. Be provided with a procedure by the use of which, immediately after the polls are
18 closed, all voting is ~~absolutely~~ prevented.
- 19 6. Be so constructed that when properly operated ~~the system~~ shall register or record
20 correctly and accurately every vote cast.
- 21 7. Be so constructed that a voter may readily learn the method of operating ~~the system~~.
- 22 8. Permit voting by ballot or by entering directly into a computer or other electronic device
23 by means of a touchscreen or other data entry device.
- 24 9. Permit voting for presidential electors by making only one mark.
- 25 10. Permit write-in voting and absentee voting.
- 26 11. Permit the rotation of names of candidates on ballots as required by this title.
- 27 12. ~~In the case of electronic systems procured after August 1, 2003, be capable of~~
28 ~~notifying a voter that the voter has overvoted, undervoted, and in the case of a primary~~
29 ~~election, cross-party voted before the voter casts a ballot.~~
- 30 13. ~~In the case of direct-recording electronic voting systems, be capable of preventing a~~
31 ~~voter from overvoting and cross-party voting before the voter casts a ballot.~~

- 1 14. ~~In the case of direct recording electronic voting systems, be capable of producing in-~~
2 ~~random order a paper copy of each ballot cast on the system.~~
- 3 15. ~~Ensure that any direct recording electronic voting system procured or used in the state-~~
4 ~~may not transmit uncounted votes or ballots through the internet.~~
- 5 16. Fulfill the criteria and standards established by the secretary of state according to
6 section 16.1-06-26.

7 **SECTION 27. AMENDMENT.** Section 16.1-06-17 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **16.1-06-17. County auditor to provide ballots and other electronic voting system**
10 **supplies.**

11 At the same time as other election supplies are provided and distributed, the county auditor
12 shall provide ~~to each precinct in the county using an electronic voting system:~~

- 13 1. A sufficient number of ~~electronic~~ voting system devices and ballots ~~if the electronic-~~

- 18 4. All other materials required to carry out the election process through the use of

20 **SECTION 28. AMENDMENT.** Section 16.1-06-18 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **16.1-06-18. Delivery of ballots.**

23 County auditors shall deliver, or cause to be delivered, by ~~mail or other~~ reliable method, to
24 the inspector of elections in each ~~precinct~~polling place the official ballots, ~~if available~~. The
25 ballots must be delivered in sealed packages marked plainly with the name of the precinct ~~for-~~
26 ~~which the ballots are intended~~. The county auditor also shall deliver or cause to be delivered a
27 suitable seal for ~~the purpose of sealing~~ the wrapper containing the ballots as provided in section
28 16.1-15-08.

29 **SECTION 29. AMENDMENT.** Section 16.1-06-19 of the North Dakota Century Code is

2 Each county auditor shall have posters printed, in large type, containing full instructions to
3 electors on obtaining and voting ballots and a copy of section 16.1-01-12, any federal laws
4 regarding prohibitions on acts of fraud and misrepresentations, and general information on
5 voting rights under applicable federal and state laws, including instructions on how to contact
6 the appropriate officials if these rights are alleged to have been violated. The county auditor
7 shall furnish at least one such poster to the election inspector in each election polling place
8 who, before the opening of the polls, shall conspicuously post at least one poster in the polling
9 place. The county auditor, at the time of delivering the ballots to the inspector of elections in
10 each polling place, shall deliver at least five copies of the newspaper publication or other copy
11 of the complete text of any constitutional amendment or initiated or referred measure to ~~such~~the
12 inspector of elections. One of the newspaper publications or copies must be posted
13 conspicuously in the polling place on the morning of the election. Each county auditor shall
14 furnish the election inspector in each polling place with four copies of a map showing the
15 election ~~precinct's~~precinct boundaries and information regarding the date of the election and the
16 hours during which polling places will be open. ~~The inspector shall, before~~Before the opening of
17 the polls, the inspector shall post the maps and information regarding the date of the election
18 and the hours during which polling places will be open at the entry to and in other conspicuous
19 places around the polling place.

20 **SECTION 30. AMENDMENT.** Section 16.1-06-25 of the North Dakota Century Code is
21 amended and reenacted as follows:

25 the secretary of state according to rules adopted under this section by April 1, 2004,
26 and must meet the requirements of the rules, or must be replaced by another

17 1. Application for an absent voter's or mail ballot must be made on a form, prescribed by
18 the secretary of state, to be furnished by the proper officer of the county, city, or school
19 district in which the applicant is an elector, ~~or~~ any form, approved by the secretary
20 of state, ~~or any blank~~ containing the following:
21 a. The applicant's name.
22 b. The applicant's current or most recent North Dakota residential address.
23 c. The applicant's mailing address.
24 d. The applicant's current contact telephone number, if available.
25 e. The election for which the ballot is being requested.

27 g. An affirmation that the applicant has resided, or will reside, in the precinct for at

- 6 j. The applicant's date of birth.
- 7 k. The identification number from one of the applicant's valid forms of identification,
8 a copy of the applicant's long-term care certificate, and, if necessary, a copy of
9 the applicant's supplemental identification under section 16.1-01-04.1.
- 10 2. If the applicant is unable to sign the applicant's name to the application, the applicant
11 shall mark (X) or use the applicant's signature stamp on the application in the
12 presence of a disinterested individual. The disinterested individual shall print the name
13 of the individual marking the X or using the signature stamp below the X or signature
14 stamp and shall sign the disinterested individual's own name following the printed
15 name together with the notation "witness to the mark".
- 16 3. If the applicant does not possess or cannot secure an approved form of identification
17 as provided for under section 16.1-01-04.1 due to a disability with which the individual
18 lives and which prevents the individual from traveling to obtain, the application also
19 must be signed by another qualified elector who, by signing, certifies that the applicant
20 is a qualified elector. The secretary of state shall prescribe the form of the certification
21 required under this subsection. An individual may not certify the qualifications of more
22 than four applicants in an election.
- 23 4. ~~The application for a uniformed service member or an immediate family member~~
24 ~~temporarily stationed away from the individual's residence in this state, or a resident of~~
25 ~~the state temporarily living outside the country~~ must include the following additional
26 information if the individual desires to access the ballot by electronic means:
 - 27 a. Facsimile telephone number; or
 - 28 b. Electronic mail address.
- 29 5. An incomplete application must be returned to the applicant for completion and
30 resubmission.

1 6. Except for the applicant's date of birth, identification card number, and any
2 supplemental documentation provided under section 16.1-01-04.1, the application is
3 an open record under section 44-04-18.

4 **SECTION 34. AMENDMENT.** Section 16.1-07-07 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **16.1-07-07. Delivering application form for ballot.**

7 The officers specified in section 16.1-07-05, upon request, shall ~~mail~~provide an application
8 form for an absent voter's ballot to the voter or may deliver the application form to the voter
9 upon a personal application made at the officer's office. The officers may also make available or
10 distribute the applications, prescribed by the secretary of state, to the public without any specific
11 request being made for the applications.

12 **SECTION 35. AMENDMENT.** Section 16.1-07-08 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **16.1-07-08. Delivering ballots - Envelopes accompanying - Affidavit on envelope -**
15 **Challenging electors voting by absentee ballot - Inability of elector to sign name.**

16 1. Upon receipt of an application for an official ballot properly filled out and duly signed,
17 or as soon ~~thereafter~~after receipt of the application as the official ballot for the precinct
18 in which the applicant resides has been prepared, the county auditor, city auditor, or
19 business manager of the school district, as the case may be, shall send to the absent
20 voter by mail or secure electronic delivery, if the secretary of state determines the
21 necessary technology is available and according to the choice made by the voter on
22 the application for the ballot, at the expense of the political subdivision conducting the
23 election, one official ballot, or personally deliver the ballot to the applicant or the
24 applicant's agent, which agent may not, at that time, be a candidate for any office to
25 be voted upon by the absent voter. The agent shall sign the agent's name before
26 receiving the ballot and deposit with the auditor or business manager of the school
27 district, as the case may be, authorization in writing from the applicant to receive the
28 ballot or according to requirements set forth for signature by mark. The auditor or
29 business manager of the school district, as the case may be, may not provide an
30 absent voter's ballot to ~~a person~~an individual acting as an agent who cannot provide a
31 signed, written authorization from an applicant. ~~No~~A person may not receive

1 compensation, including money, goods, or services, for acting as an agent for an
2 elector, ~~nor~~ and a person may ~~a person~~ not act as an agent for more than four electors
3 in any one election. A voter voting by absentee ballot may not require the political
4 subdivision providing the ballot to bear the expense of the return postage for an
5 absentee ballot.

6 2. With the exception provided in section 16.1-07-24 for secure remote electronic casting
7 of a ballot granted to a covered voter, the absent voter marking the ballot by electronic
8 means shall return the instrument containing the vote selections made by the voter to
9 the assigned polling place where, after being recorded in the pollbook by a poll clerk,
10 the choices listed in the instrument will be converted into the official ballot. Upon
11 confirmation by the voter the vote selections marked by the ballot marking device are
12 correct, the voter shall cast the ballot in the tabulation device.

13 3. If there is more than one ballot to be voted by an elector of the precinct and the voting
14 system will be unable to tabulate one or more of the ballots, one of each kind must be
15 included and a secrecy envelope and a return envelope must be enclosed with the
16 ballot or ballots. The front of the return envelope must bear the official title and
17 post-office address of the officer supplying the voter with the ballot and upon the other
18 side a printed voter's affidavit in substantially the following form:

31 this section, the voter shall mark (X) or use the applicant's signature stamp on the

3 X or signature stamp and shall sign the disinterested individual's own name following
4 the printed name together with the notation "witness to the mark".

5 ~~3-5.~~ Each individual requesting an absent voter's ballot under this chapter must be
6 provided a set of instructions, prescribed by the secretary of state, sufficient to
7 describe the process of voting by absent voter's ballot. The voting instructions must
8 contain a statement informing the individual that the individual is entitled to complete
9 the absent voter's ballot in secrecy.

10 ~~4-6.~~ Each individual requesting an absent voter's ballot by mail under this chapter who
11 cannot read the English language or ~~who because of blindness or other~~lives with a
12 ~~disability is unable to mark~~preventing the individual from marking the voter's ballot,
13 ~~upon request,~~ may receive, upon request, the assistance of any individual of the
14 voter's choice, other than the voter's employer, an officer or agent of the voter's union,
15 a candidate running in that election, or a relative of a candidate as described in
16 subsection 2 of section 16.1-05-02, in marking the voter's ballot.

17 7. An election official shall deliver an absentee ballot to a qualified elector only upon
18 receipt of an application meeting the requirements of section 16.1-07-06 from the
19 elector.

20 **SECTION 36. AMENDMENT.** Section 16.1-07-09 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **16.1-07-09. Canvassing of mailed absent voter's ballots received late.**

23 In ~~the case of~~ congressional, state, county, city, or school district elections, if an envelope
24 postmarked or otherwise officially marked by the United States postal service or other mail
25 delivery system before the date of election and containing an absent voter's ballot is received by
26 the officer ~~too late to be forwarded to a polling place of the proper voting precinct in time to be~~
27 ~~tabulated~~after election day, the ballot must be tallied by the canvassing board of the county, the
28 governing body of the city, or the school board of the school district, as the case may be, at the
29 time the returns are canvassed. Any envelope without a postmark or other official marking by
30 the United States postal service or other mail delivery system or with an illegible postmark or
31 other official marking and containing an absentee voter's ballot must be received by mail by the

1 proper officer prior to the meeting of the canvassing board. An absent voter may personally
2 deliver the absent voter's ballot to the appropriate officer's office at any time before five p.m. on
3 the day before the election. Any envelope containing an absent voter's ballot with a postmark or
4 official date stamp on the day of election or thereafter may not be tallied with the ballots timely
5 submitted for the election. Before forwarding any ballot to a canvassing board pursuant to this
6 section, the officer forwarding the ballot shall print the date of receipt on the envelope. Upon
7 receipt, the canvassing board shall determine that the elector was qualified to vote in that
8 precinct, that the elector did not previously vote in that precinct on the date of the election, and
9 that the signatures on the absentee ballot application and the voter's affidavit were signed by
10 the same ~~person~~individual before allowing the ballot to be tallied.

11 **SECTION 37. AMENDMENT.** Section 16.1-07-10 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **16.1-07-10. Care and custody of ballot - Submitted ballot may not be returned.**

14 Upon receipt of an envelope containing the absent voter's ballot, the proper officer
15 immediately shall attach the application of the absent voter and file the ballot with other
16 absentee ballots from the same precinct. If the election official has reason to suspect the
17 signature on the application was made by a different individual than the individual who signed
18 the affidavit on the return ballot envelope, the election official shall attempt to contact the absent
19 voter as soon as practicable to provide an opportunity to validate the signatures. Contact shall
20 first be attempted by phone if the absent voter provided a phone number on the submitted
21 application. If the election official is unable to speak with the absent voter, the election official
22 shall mail a notice informing the absent voter the absentee ballot has been identified as having
23 a signature mismatch and will be rejected if not verified. After submission to the appropriate
24 election officer, a marked absent voter's ballot may not be returned to the voter for any reason
25 other than to complete any missing information required on the affidavit on the back of the
26 return envelope. Before delivering the absentee ballots to ~~a polling place of the proper~~the
27 absentee ballot precinct, the proper officer shall package the ballots in a manner so the ballots
28 are sealed securely. The package must be endorsed with the name of the proper voting
29 precinct, the name and official title of the officer, and the words "This package contains an
30 absent voter's ballot and must be opened only according to the processing provisions of section

1 16.1-07-12." The officer shall keep the package safely in the officer's office until ~~it~~the package is
2 delivered by the officer as provided in this chapter.

3 **SECTION 38. AMENDMENT.** Subsection 1 of section 16.1-07-12.1 of the North Dakota
4 Century Code is amended and reenacted as follows:

5 1. For any primary, general, or special statewide, district, or county election, the board of
6 county commissioners ~~may~~shall create a special precinct, known as an absentee
7 ballot precinct, ~~for the purpose of counting~~to count all absentee ballots cast in an
8 election in that county. The election board of the absentee ballot precinct must be
9 known as the absentee ballot counting board. The county auditor shall supply the
10 board with all necessary election supplies as provided in chapter 16.1-06.

11 **SECTION 39.** Section 16.1-07-13.1 of the North Dakota Century Code is created and
12 enacted as follows:

13 **16.1-07-13.1. Signature mismatch - Verification of signatures.**

14 1. If an election official, absentee ballot precinct election board, or the canvassing board
15 has reason to suspect the absent voter's signatures on the application and the affidavit
16 on the returned ballot envelope do not match, the election official shall notify the
17 absent voter the signatures do not appear to match. The notification must include
18 instructions by which the absent voter may confirm the validity of the signatures, a
19 statement that verification is required before the ballot can be counted, the date and
20 time of the canvassing board meeting, and a statement that verification must be
21 completed by the absent voter before close of the meeting of the canvassing board
22 occurring six days after the election.

23 2. The absent voter may confirm the validity of the signatures by written communication
24 or personal visit to the office of the election official administering the election. If the
25 voter confirms by written communication, the written communication must include a
26 copy of the identification used when applying for the ballot. If the voter confirms
27 through a personal visit to the election official, the voter must show the identification
28 used when applying for the ballot. The election official shall make a copy of the
29 identification shown, and the copy must be included with the application and ballot
30 when provided to the election board or canvassing board, whichever would be
31 appropriate based on when the voter verified the signatures. The canvassing board

1 shall include in the final tally the ballot from an absent voter who has completed the
2 verification process and was eligible to vote the returned ballot.

3 3. An individual contacted regarding the mismatch of signatures may deny making the
4 application or returning the ballot. The election official receiving the denial shall turn
5 the application and uncounted ballot over to the county state's attorney for
6 investigation of attempted voter fraud.

7 4. The election official shall record in the minutes of the county canvassing board the
8 manner and number of attempts made to contact an absent voter for signature
9 verification, the number of ballots included in the tally because the signatures were
10 verified, and the number of ballots ultimately rejected by the canvassing board along
11 with the reasons for the rejections.

12 5. After the meeting of the canvassing board, the election official shall send a written
13 notice to each absent voter whose ballot was rejected and not counted because of
14 signature mismatch.

15 **SECTION 40. AMENDMENT.** Section 16.1-07-15 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **16.1-07-15. Early voting precinct - Election board appointment - Closing and**
18 **canvassing.**

19 1. For any primary, general, or special statewide, district, or county election, the board of
20 county commissioners may, before the sixty-fourth day before the day of the election,
21 create a special precinct, known as an early voting precinct, to facilitate the conduct of
22 early voting in that county according to ~~chapters 16.1-13 and 16.1-15~~this title. At the
23 determination of the county auditor, more than one polling place may be utilized for the
24 purposes of operating the early voting precinct. The election board of the early voting
25 precinct must be known as the early voting precinct election board. The county auditor
26 shall supply the board with all necessary election supplies as provided in chapter
27 16.1-06.

28 2. If the board of county commissioners establishes an early voting precinct according to
29 this section, the following provisions apply:

30 a. Early voting must be authorized during the fifteen days immediately before the
31 day of the election. The county auditor shall designate the business days and

- 1 times during which the early voting election precinct will be open and publish
2 notice of the early voting center locations, dates, and times in the official county
3 newspaper once each week for three consecutive weeks immediately before the
4 day of the election.
- 5 b. The county auditor shall appoint the early voting precinct election board for each
6 early voting polling place that consists of one independent representative to act
7 as the inspector and an equal number of representatives from each political party
8 represented on an election board in the county, as set out in section 16.1-05-01,
9 to act as judges. Each official of the board shall take the oath required by section
10 16.1-05-02 and must be compensated as provided in section 16.1-05-05.
- 11 c. The county auditor, with the consent of the board of county commissioners, shall
12 designate each early voting polling place in a public facility, accessible to the
13 elderly and the physically disabled as provided in section 16.1-04-02. With
14 respect to polling places at early voting precincts, "election day" as used in
15 sections 16.1-10-03 and 16.1-10-06.2 includes any time an early voting precinct
16 polling place is open.
- 17 d. At the close of each day of early voting, the inspector, along with a judge from
18 each political party represented on the board, shall secure all election-related
19 materials, including:
- 20 (1) The pollbooks and access to any electronically maintained pollbooks.
21 (2) The ballot boxes containing voted ballots.
22 (3) Any void, spoiled, and unvoted ballots.
- 23 e. Ballot boxes containing ballots cast at an early voting polling place may not be
24 opened until the day of the election except as may be necessary to clear a ballot
25 jam or to move voted ballots to a separate locked ballot box in order to make
26 room for additional ballots.
- 27 f. Each early voting polling place may be closed, as provided in chapter 16.1-15, at
28 the end of the last day designated for early voting in the county. Results from the
29 early voting precinct may be counted, canvassed, or released under chapter
30 16.1-15 as soon as any precinct within the county, city, or legislative district
31 closes its polls on the day of the election. The county auditor shall designate a

1 location for the closing, counting, and canvassing process under chapter 16.1-15,
2 which location must be open to any person for the purpose of observing.

3 g. The early voting precinct election board shall comply with the requirements of
4 chapters 16.1-05, 16.1-06, 16.1-11, 16.1-11.1, 16.1-13, and 16.1-15, as
5 applicable.

6 **SECTION 41. AMENDMENT.** Section 16.1-08.1-01 of the North Dakota Century Code is

22 or license fees in any amount, or which maintains a treasury fund in any amount. The
23 term does not include corporations, cooperative corporations, limited liability
24 companies, political committees, or political parties.
- 25 3. ~~"Candidate" means an individual who seeks nomination for election or election to-~~
26 ~~public office, and includes:~~
- 27 a. ~~An individual holding public office;~~
- 28 b. ~~An individual who has publicly declared that individual's candidacy for nomination~~
29 ~~for election or election to public office or has filed or accepted a nomination for~~
30 ~~public office;~~

- 1 e. ~~An individual who has formed a campaign or other committee for that individual's-~~
2 ~~candidacy for public office;~~
- 3 d. ~~An individual who has circulated a nominating petition to have that individual's-~~
4 ~~name placed on the ballot; and~~
- 5 e. ~~An individual who has, in any manner, solicited or received a contribution for that-~~
6 ~~individual's candidacy for public office, whether before or after the election for-~~
7 ~~that office.~~
- 8 4. "Conduit" means a person that is not a political party, political committee, or candidate
9 and which receives a contribution of money and transfers the contribution to a
10 candidate, political party, or political committee when the contribution is designated
11 specifically for the candidate, political party, or political committee and the person has
12 no discretion as to the recipient and the amount transferred. The term includes a
13 transactional intermediary, including a credit card company or a money transfer
14 service that pays or transfers money to a candidate on behalf of another person.
- 15 5.4. "Contribution" means a gift, transfer, conveyance, provision, receipt, subscription,
16 loan, advance, deposit of money, or anything of value, made for the purpose of
17 influencing the nomination for election, or election, of any person to public office or
18 aiding or opposing the circulation or passage of a statewide initiative or referendum
19 petition or measure. The term also means a contract, promise, or agreement, express
20 or implied, whether or not legally enforceable, to make a contribution for any of the
21 above purposes. The term includes funds received by a candidate for public office or a
22 political party or committee which are transferred or signed over to that candidate,
23 party, or committee from another candidate, party, or political committee or other
24 source including a conduit. The term "anything of value" includes any good or service
25 of more than a nominal value. The term "nominal value" means the cost, price, or
26 worth of the good or service is trivial, token, or of no appreciable value. The term
27 "contribution" does not include:
- 28 a. A loan of money from a bank or other lending institution made in the regular
29 course of business.
- 30 b. Time spent by volunteer campaign or political party workers.

- 1 c. Money or anything of value received for commercial transactions, including rents,
2 advertising, or sponsorships made as a part of a fair market value bargained-for
3 exchange.
- 4 d. Money or anything of value received for anything other than a political purpose.
- 5 e. Products or services for which the actual cost or fair market value are reimbursed
6 by a payment of money.
- 7 f. An independent expenditure.
- 8 g. The value of advertising paid by a political party, multicandidate political
9 committee, or caucus which is in support of a candidate.
- 10 h. In-kind contributions from a candidate to the candidate's campaign.
- 11 ~~6-5.~~ "Cooperative corporations", "corporations", and "limited liability companies" are as
12 defined in this code, and for purposes of this chapter "corporations" includes nonprofit
13 corporations. However, if a political committee, the only purpose of which is accepting
14 contributions and making expenditures for a political purpose, incorporates for liability
15 purposes only, the committee is not considered a corporation for the purposes of this
16 chapter.
- 17 ~~7-6.~~ "Expenditure" means:
- 18 a. A gift, transfer, conveyance, provision, loan, advance, payment, distribution,
19 disbursement, outlay, or deposit of money or anything of value, except a loan of
20 money from a bank or other lending institution made in the regular course of
21 business, made for a political purpose or for the purpose of influencing the
22 passage or defeat of a measure.
- 23 b. A contract, promise, or agreement, express or implied, whether or not legally
24 enforceable, to make any expenditure.
- 25 c. The transfer of funds by a political committee to another political committee.
- 26 d. An independent expenditure.
- 27 ~~8-7.~~ "Expenditure categories" means the categories into which expenditures must be
28 grouped for reports under this chapter. The expenditure categories are:
- 29 a. Advertising;
- 30 b. Campaign loan repayment;
- 31 c. Operations;

1 d. Travel; and

2 e. Miscellaneous.

3 ~~9.8.~~ "Independent expenditure" means an expenditure made for a political purpose or for
4 the purpose of influencing the passage or defeat of a measure if the expenditure is
5 made without the express or implied consent, authorization, or cooperation of, and not
6 in concert with or at the request or suggestion of, any candidate, committee, or
7 political party.

8 ~~40.9.~~ "Patron" means a person who owns equity interest in the form of stock, shares, or
9 membership or maintains similar financial rights in a cooperative corporation.

10 ~~44.10.~~ "Person" means an individual, partnership, political committee, association,
11 corporation, cooperative corporation, limited liability company, or other organization or
12 group of persons.

13 ~~42.11.~~ "Personal benefit" means a benefit to the candidate or another person which is not for
14 a political purpose or related to a candidate's responsibilities as a public officeholder,
15 and any other benefit that would convert a contribution to personal income.

16 ~~43.12.~~ "Political committee" means any committee, club, association, or other group of
17 persons which receives contributions or makes expenditures for political purposes and
18 includes:

- 19 a. A political action committee not connected to another organization and free to
20 solicit funds from the general public, or derived from a corporation, cooperative
21 corporation, limited liability company, affiliate, subsidiary, or an association that
22 solicits or receives contributions from its employees or members or makes
23 expenditures for political purposes on behalf of its employees or members;
- 24 b. A candidate committee established to support an individual candidate seeking
25 public office which solicits or receives contributions for political purposes;
- 26 c. A political organization registered with the federal election commission, which
27 solicits or receives contributions or makes expenditures for political purposes;

6 the secretary of state for the circulation of a petition, or seeking approval of the

9 candidate for election to any office which may be filled by a vote of the electors of this
10 state or any of its political subdivisions and whose name appears on the election ballot
11 as the candidate of such association, committee, or organization.

12 ~~45.14.~~ "Political purpose" means any activity undertaken in support of or in opposition to the
13 election or nomination of a candidate to public office and includes using "vote for",

However, the petition or certificate of endorsement must be complete and in the possession of the county auditor before four p.m. on the sixty-fourth day before the primary election. A petition under this section must include the following:

1. The candidate's name, post-office address, and telephone number, the title of the office to which the candidate aspires, the appropriate district number if applicable, and whether the petition is intended for nomination for an unexpired term of office if applicable.
2. The printed names and signatures of qualified electors, the number of which must be determined as follows:
 - a. If the office is a county office, the signatures of not less than two percent of the total vote cast for the office at the most recent general election at which the office was voted upon.
 - b. If the office is a county office and multiple candidates were elected to the office at the preceding general election at which the office was voted upon, the signatures of not less than two percent of the votes cast for all candidates divided by the number of candidates that were to be elected to that office.

1 c. If the office is a county office and no candidate was elected or no votes were cast
2 for the office at any general election, the number of signers equal to ~~the~~
3 ~~percentage as provided in paragraph 1~~ applied to at least two percent of the total
4 average vote cast for the offices of sheriff and county auditor at the most recent
5 general election at which those officers were elected in the petitioner's county.
6 This average must be determined by dividing by two the total vote cast for those

21 four p.m. on the sixty-fourth day before the general election.

10 exists. ~~If such petition is mailed or otherwise delivered, it must be in the possession of~~

13 signed by qualified electors equal in number to at least thirty percent of the total vote

26 or by personal delivery, and must be complete and in the possession of the filing
27 officer before four p.m. on the sixty-fourth day before the general or special election.

28 **SECTION 70.** Section 16.1-12-10 of the North Dakota Century Code is created and enacted
29 as follows:

1 **16.1-12-10. Party committee to fill vacancy occurring after nomination for party office.**

2 1. If a vacancy occurs in a slate of statewide candidates after the candidates have been
3 nominated at the primary election, the state executive committee of the party that
4 submitted the slate of statewide candidates may fill the vacancy by filing a certificate of
5 nomination with the secretary of state. The chairman and secretary of the committee
6 shall make and file with the secretary of state a certificate setting forth the cause of the
7 vacancy, the name of the individual for whom the new nominee is to be substituted,
8 the fact the committee was authorized to fill vacancies, and any other information
9 required to be provided in an original certificate of nomination. When the certificate of
10 nomination to fill a vacancy is filed, the secretary of state shall certify the new

14 auditors the name and address of the new nominee, the office the new nominee is

17 Failure to publish the name of a new nominee does not invalidate the election.

18 2. If a vacancy occurs in a slate of legislative candidates after the candidates have been
19 nominated at the primary election, the executive committee of the district in which the
20 vacancy occurs and of the party that submitted the slate of legislative candidates may
21 fill the vacancy by filing a certificate of nomination with the secretary of state. The
22 chairman and secretary of the committee shall make and file with the secretary of
23 state a certificate setting forth the cause of the vacancy, the name of the individual for
24 whom the new nominee is to be substituted, the fact the committee was authorized to
25 fill vacancies, and any other information required to be provided in an original
26 certificate of nomination. When the certificate of nomination to fill a vacancy is filed,
27 the secretary of state shall certify the new nomination to the various county auditors
28 affected by the change by forwarding to the auditors the name of the individual who
29 has been nominated to fill the vacancy in place of the original nominee, as soon as
30 possible. The certification must include the name and address of the new nominee,
31 the office the new nominee is nominated for, the party or political principle the new

1 nominee represents, and the name of the individual for whom the new nominee is
2 substituting. Failure to publish the name of a new nominee does not invalidate the
3 election.

4 3. A vacancy in a nomination following a primary election may not be filled according to

8 c. Ceases to be a resident of the state;

9 d. Is nominated to be a member of the legislative assembly and, at the time of the

10 Sample ballots used for publication purposes must be arranged using the rotation of

14 The arrangement of candidate names appearing on ballots in your precinct may vary

20 secretary of state within thirty days following an appointment being made according to
21 subsection 1. If the secretary of state determines the petition contains the required

24 called to fill the vacancy. Upon receiving such notice, the governor shall issue a writ of

10 ~~and an oath of office for the appointee to complete and file with the secretary of state.~~

11 **SECTION 73.** A new section to chapter 16.1-13 of the North Dakota Century Code is

15 becomes disqualified for the office receives enough votes to be elected except for the death or

19 **SECTION 76. AMENDMENT.** Section 16.1-13-18 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **16.1-13-18. Two or more organizations filing certificates representing same party -**
22 **Secretary of state to determine authorized organization - Review of determination.**

23 If two or more organizations claiming or purporting to represent the same political party
24 shall file certificates of nomination under the same party designation, or if the certificates
25 indicate ~~that~~ the nominations were made by any ~~person~~individual or organization representing

18 be seen. The elector then shall deposit the ballot in the optical scanning device and wait to
19 determine if the ballot is deposited into the ballot box or if the optical scanning device has
20 indicated a possibility for a second-chance voting condition. If a second-chance voting condition
21 is indicated, a voter may spoil and receive up to two additional ballots. The voter's third ballot
22 must be cast as is and may not be returned to the voter even if errors exist causing certain
23 votes not to be counted.

24 **SECTION 79. AMENDMENT.** Section 16.1-13-25 of the North Dakota Century Code is

11 requests assistance, may not divulge to anyone within the polling place the name of any
12 candidate for whom the elector intends to vote, nor ask, nor receive the assistance of any
13 ~~person~~individual within the polling place to mark the elector's ballot. Parking facilities at polling
14 places must be accessible to individuals living with physical disabilities and the elderly and the
15 ~~physically disabled,~~ and must be clearly marked.

28 "scattered write-ins".

22 and the total number of votes cast for or against any measure appearing on the ballot.

29 substituted for the damaged or defective ballot. All duplicate ballots must be ~~clearly~~

1 damaged or defective ballot, and must be wrapped and delivered with other ballots to

5 **SECTION 102. AMENDMENT.** Section 16.1-15-47 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **16.1-15-47. Certificate of election to member of Congress - Signing - Delivering.**

8 The certificate of election to a member of Congress must be signed by the governor with
9 the great seal affixed and must be countersigned by the secretary of state. The governor shall
10 cause the certificate to be delivered to the ~~person~~individual elected.

11 **SECTION 103. AMENDMENT.** Section 16.1-16-01 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **16.1-16-01. Election recounts.**

14 A recount of any primary, special, or general election for nomination or election to a
15 presidential, congressional, state, judicial district, multicounty district, legislative, county, or city
16 office, or for the approval or disapproval of any measure, question, or bond issue submitted to
17 the qualified electors of this state or one of its political subdivisions must be conducted
18 according to guidelines established by the secretary of state and as follows:

- 19 1. A recount must be conducted when:
- 20 a. Any individual failed to be nominated by the individual's party or to a no-party
21 office in a primary election by one percent or less of the highest vote cast for a
22 candidate seeking nomination from the political party for the office sought or for a
23 candidate for the no-party office sought.
- 24 b. Any individual failed to be elected in a general or special election by one-half of
25 one percent or less of the highest vote cast for a candidate for that office.
- 26 c. A question, measure, or bond issue submitted to the qualified electors has been
27 decided by a margin not exceeding one-fourth of one percent of the total vote
28 cast for and against the question at any election.
- 29 2. A demand for a recount may be made by any of the following:
- 30 a. Any individual who failed to be nominated by the individual's party or to a
31 no-party office in a primary election by more than one percent and less than two

- 1 percent of the highest vote cast for a candidate seeking nomination from the
2 political party for the office sought or for a candidate for the no-party office
3 sought.
- 4 b. Any individual who failed to be elected in a general or special election by more
5 than one-half of one percent and less than two percent of the highest vote cast
6 for a candidate for that office.
- 7 3. A demand for a recount must be made within three days after the canvass of the votes
8 by the county canvassing board in the case of county elections and city elections that
9 are combined with the county and by the state canvassing board in the case of
10 presidential, congressional, state, judicial district, multicounty district, or legislative
11 elections. The demand must be in writing, must recite one of the conditions in
12 subsection 2 as a basis for the recount, must contain a bond in an amount previously
13 established by the auditor or auditors doing the recount sufficient to pay the cost of the
14 recount, and must be filed with:
- 15 a. The secretary of state when the recount is for a congressional, state, district, or
16 legislative office.
- 17 b. The county auditor when the recount is for a county office or city office when a
18 city election is combined with the county.
- 19 4. Within four days after the canvass of the votes by the state canvassing board in the
20 case of presidential, congressional, state, judicial district, multicounty district, or
21 legislative elections, the secretary of state shall notify all the county auditors to
22 conduct recounts as required by subsection 1 and, when a timely recount demand is
23 received and it is in proper form, as required by subsection 2. The secretary of state
24 shall fix the date or dates of the recounts of legislative contests to be held within seven
25 days after giving notice to the affected auditors that recounts must be conducted. The
26 secretary of state shall fix the date or dates of the recounts of statewide races to be
27 held within fourteen days after giving notice to the auditors that recounts must be
28 conducted. Within four days after the canvass of votes by the county canvassing
29 board or other political subdivision canvassing board, the county auditor or other
30 political subdivision election official shall fix the date for recounts limited to the county,
31 those cities within the county which combined the election with the county, or other

1 political subdivision. The date must be within eight days after the canvass. In all
2 recount proceedings, the county auditor or other election official, as appropriate, shall
3 send notice of the date, place, and time of the recount to all candidates and petitioners
4 involved by certified mail.

- 5 5. For recounts conducted by counties of federal, state, district, and county offices,
6 measures, and questions, the county auditor must conduct the recount and may
7 employ up to ten qualified electors of the county to assist in the recount. The county
8 auditor shall review all properly cast ballots and associated records. The county
9 auditor shall check the precinct count and the count of the county canvassing board. If
10 the county auditor is a candidate involved in the recount, the county auditor is
11 disqualified from acting thereon, and the county recorder shall perform the duties
12 required of the county auditor by this section. For recounts conducted by political
13 subdivisions other than counties of local offices, measures, and questions, the election
14 officer in a political subdivision shall administer a recount in the same manner as is
15 required under this subsection for counties with respect to political subdivision offices,
16 ballot measures, questions, or bond issues.

- 17 6. a. The individuals entitled to participate at the recount are:
18 (1) Each candidate involved in the recount, either personally or by a
19 representative.
20 (2) A qualified elector favoring each side of a question if the recount involves a
21 question or proposition submitted to a vote of the electorate.
22 b. The individuals allowed to participate may challenge the acceptance or exclusion
23 of any ballot. The individual challenging a ballot must state the reason for the
24 challenge based upon the law, and the county auditor or other political
25 subdivision election official shall count the challenged ballot as the auditor or
26 election official determines proper and then shall set the ballot aside with a
27 notation that it was challenged and how it was counted.

- 28 7. At the conclusion of the recount, the county auditor or other election official shall
29 submit all challenged ballots to the recount board for decision. Except for political
30 subdivision recounts other than counties, the recount board must be composed of the
31 state's attorney of the county, the chairman of the board of county commissioners, and

1 the county recorder. Unless otherwise specified by law, for a political subdivision other
2 than a county, the governing body of the political subdivision shall appoint the recount
3 board. An individual may not serve on the recount board if the individual has anything
4 of value bet or wagered on the result of the election, is a candidate for the office being
5 recounted, or is the husband, wife, father, mother, father-in-law, mother-in-law, son,
6 daughter, son-in-law, daughter-in-law, brother, or sister, whether by birth or marriage,
7 of the whole or the half-blood, of any candidate involved in the recount. If any of the
8 members of the recount board are disqualified or cannot serve for any other reason,
9 the members of the board of county commissioners or other political subdivision
10 governing body who would be qualified to serve on the board shall appoint
11 disinterested qualified electors of the county or other political subdivision to serve as
12 alternates. The recount board shall review all challenged ballots and on majority vote
13 shall decide how those ballots are counted. The decision of the recount board is final,
14 subject to the right to contest the election as provided in this chapter. If during the
15 recount a recess is called, the county auditor or other political subdivision election
16 official shall take appropriate steps to safeguard the ballots.

17 8. The county auditor or other election official shall certify the results of the recount
18 immediately after the recount. The recount result is the official result of the election in
19 the county or other political subdivision. The county auditor or other election official
20 shall prepare a corrected abstract of the votes. In a recount limited to the county, city,
21 or other political subdivision, if the corrected abstract shows no change in the outcome
22 of the election, no further action may be taken. If the corrected abstract changes the
23 outcome of the election, the county auditor or other election official shall issue
24 certificates of nomination or election accordingly and shall certify the new result of a
25 question submitted to the qualified electors. In the case of a city election that is
26 combined with a county election, the county auditor shall certify the new results of the
27 election to the city auditor who is responsible for issuing new certificates of election if
28 applicable.

29 9. In presidential, congressional, statewide, judicial district, multicounty district, or
30 legislative recounts, the county auditor, immediately after the recount, shall submit
31 electronically the corrected abstract to the secretary of state according to the

1 instructions provided by the secretary of state. The secretary of state immediately shall
2 assemble the state canvassing board, who shall canvass the corrected abstracts and
3 certify the election results. The secretary of state shall issue certificates of election or
4 nomination or record the approval or disapproval of a question submitted to the
5 qualified electors accordingly.

6 10. The expenses incurred in a recount of a county election must be paid by the county on
7 a warrant by the county auditor. The expenses incurred in a recount of a political
8 subdivision other than a county election must be paid by that political subdivision. The
9 expenses incurred in a recount of a city election must be paid by the city on a warrant
10 by the city auditor. The expenses incurred in a recount of a presidential,
11 congressional, state, judicial district, multicounty district, or legislative election must be
12 paid by the state from the general fund upon approval by the secretary of state of a
13 statement of expenses received from the county auditors. The expenses incurred in a
14 recount demanded under subsection 2 of section 16.1-16-01 must be paid by the
15 secretary of state or county auditor from the bond submitted by the individual
16 requesting the recount.

17 11. This section also applies to city elections that are not combined with the county except
18 the city auditor, to the extent applicable, shall perform the duties of the county auditor.

19 **SECTION 104. AMENDMENT.** Section 16.1-16-02 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **16.1-16-02. Who may contest election.**

22 A defeated candidate or ten qualified electors may contest the nomination or election of any
23 person or the approval or rejection of any question or proposition submitted to a vote of the
24 electorate, pursuant to ~~chapters 16.1-04, 16.1-05, 16.1-06, 16.1-07, 16.1-08.1, 16.1-09,~~
25 ~~16.1-10, and 16.1-11~~this title. In a county election to change the county seat or to change the
26 boundaries of the county, the complaint must be filed against the board of county
27 commissioners, ~~wh~~which shall appear and defend the contest action.

28 **SECTION 105. AMENDMENT.** Section 16.1-16-07 of the North Dakota Century Code is
29 amended and reenacted as follows:

1 **16.1-16-07. Contest involving irregularity of ballots - Preservation of ballots.**

2 Either the contestant or the contestee, within the time provided by this title for the
3 preservation of ballots, may give notice by certified mail to the county recorder of any county
4 where the contestant or the contestee desires the ballots preserved, that an election contest is
5 pending in a designated court. ~~Thereupon, it is the duty of~~After receipt of the notice, the county
6 recorder ~~to~~shall preserve all the ~~paper~~ ballots and ~~electronic voting system ballots and~~
7 associated records until the contest has been finally determined or the retention period
8 specified in section 16.1-15-13 has ended, whichever is later.

9 **SECTION 106. AMENDMENT.** Section 44-02-03 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **44-02-03. Vacancy in state or district office - How filled.**

12 Any vacancy in a state or district office, except in the office of a member of the legislative
13 assembly, must be filled by appointment by the governor. The governor may not fill a vacancy in
14 the office of a member of the legislative assembly. A vacancy in the office of a supreme court
15 justice or district court judge must be filled as provided in chapter 27-25. If during a vacancy in
16 the office of governor, the lieutenant governor and the secretary of state are impeached,
17 displaced, resign, or die, or from mental or physical disease or otherwise become incapable of
18 performing the duties of the office of governor as provided by sections 2 and 7 of article V of the
19 Constitution of North Dakota, then the succession to the office of governor is the speaker of the
20 house, president pro tem of the senate, attorney general, in the order named. Each succeeding
21 person named shall hold the office of governor until the vacancy is filled by election or until any
22 disability of the preceding person in the line of succession is removed.

23 **SECTION 107.** Section 44-02-03.1 of the North Dakota Century Code is created and
24 enacted as follows:

25 **44-02-03.1. Vacancy in legislative assembly.**

26 1. If a vacancy in the office of a member of the legislative assembly occurs, the secretary
27 of state shall notify the chairman of the legislative management of the vacancy. The
28 secretary of state need not notify the chairman of the legislative management of the
29 resignation of a member of the legislative assembly when the resignation was made
30 under section 44-02-02.

1 2. Upon receiving notification of a vacancy, the chairman of the legislative management
2 shall notify the district committee of the political party the former member represented,
3 or the member-elect or deceased or disqualified candidate would have represented, in
4 the district in which the vacancy exists. The district committee shall hold a meeting
5 within twenty-one days after receiving the notification and select an individual to fill the
6 vacancy. If the former member, member-elect, or deceased or disqualified candidate
7 was elected as an independent candidate or if the district committee does not make an
8 appointment within twenty-one days after receiving the notice from the chairman of the
9 legislative management, the chairman of the legislative management shall appoint a
10 resident of the district to fill the vacancy.

11 3. If a vacancy occurs because a member-elect died or became disqualified, or a
12 candidate who died or became disqualified received a sufficient number of votes to be
13 elected except for the death or disqualification, the term of an individual appointed to
14 fill the vacancy begins on the first day of December of the year in which the vacancy
15 occurs.

16 4. Except as provided in subsection 6:

17 a. If the office with the vacancy would not have been placed on the next general
18 election ballot after the vacancy occurs had the member, member-elect, or
19 candidate whose death, disqualification, or resignation created the vacancy been
20 able and qualified to fulfill the term, the individual appointed to fill the vacancy
21 shall serve until a successor is elected at and qualified following the next general
22 election that is at least ninety-four days after the vacancy occurs.

23 b. If the office with the vacancy would have been placed on the next general
24 election ballot after the vacancy occurs had the member, member-elect, or
25 candidate whose death, disqualification, or resignation created the vacancy been
26 able and qualified to fulfill the term and:

27 (1) The next general election is scheduled to take place less than ninety-four
28 days after the vacancy occurs:

29 (a) The individual appointed to fill the vacancy shall serve until a
30 successor is elected at and qualified following the next general
31 election that is at least ninety-four days after the vacancy occurs; and

1 (b) The elected successor shall serve through November thirtieth of the
2 following even-numbered year.

3 (2) The next general election is scheduled to take place at least ninety-four
4 days after the vacancy occurs, the individual appointed shall serve until a
5 successor is elected at and qualified following the next general election.

6 5. If a special election to fill the vacancy is called by the governor according to
7 subsection 6, the individual elected at the special election shall serve for the
8 remainder of the term of office which would have been served by the individual whose
9 death, disqualification, or resignation created the vacancy.

10 6. The qualified electors of a legislative district in which a vacancy in the office of a
11 member of the legislative assembly occurs due to the death, disqualification, or
12 resignation of a member of the legislative assembly during the member's term of office
13 may petition for a special election to be called by the governor to fill the vacancy. The
14 petition must include the signatures of qualified electors equal in number to at least
15 four percent of the resident population of the legislative district as determined by the
16 last federal decennial census and must be presented to the secretary of state within
17 thirty days following an appointment being made according to subsection 2. If the
18 secretary of state determines the petition contains the required number of signatures
19 of qualified electors of the affected legislative district, the secretary of state shall notify
20 the governor that a special election is required to be called to fill the vacancy. Upon
21 receiving the notice, the governor shall issue a writ of election directed to the secretary
22 of state commanding the secretary of state to hold a special election to fill the vacancy
23 at a time designated by the governor. A special election under this section must
24 conform to the applicable election deadlines found in title 16.1 and may be called to
25 coincide with a regularly scheduled primary or general election provided the special
26 election is called by the fifteenth day before the deadline for candidates to file for office
27 before a regularly scheduled primary or general election. A special election under this
28 section may not be scheduled to occur during the time from a general election through
29 eighty days following the adjournment of the next ensuing regular session of the
30 legislative assembly.

- 1 7. The secretary of state must be notified of an appointment made by a district committee
2 or the chairman of the legislative management according to this section. Upon
3 notification, the secretary of state shall issue the appointee a certificate of appointment
4 and an oath of office for the appointee to complete and file with the secretary of state.
5 8. For purposes of addressing vacancies in offices of members of the legislative
6 assembly, an individual is disqualified for an office if the individual fails to meet the
7 qualifications under law for the office.

8 **SECTION 108.** A new section to chapter 54-09 of the North Dakota Century Code is
9 created and enacted as follows:

10 **Criminal History Record Check.**

11 The secretary of state may require any employee who has access to personally identifying
12 information of residents or businesses of the state, or access to election systems that are
13 critical infrastructure under section 44-04-24, to submit to a statewide and nationwide criminal
14 history record check. The criminal history record check must be conducted as provided by
15 section 12-60-24.

16 **SECTION 109. REPEAL.** Sections 16.1-06-10.1, 16.1-07-11, 16.1-07-13, ~~and~~ 16.1-13-10,
17 16.1-13-24, and 54-03-01.13 of the North Dakota Century Code are repealed.
