

**State Health Officer:**

Page 31, line 19, removes "health officer" from the definition.

Page 31, lines 28 and 29, updates health officer to the department (department of health and human services)

Page 56, lines 4 through 31, removes the Governor from appointing the state health officer and places that authority with the executive director of the health and human services. The amendments also remove the requirement that the state health officer not engage in any other occupation or business that may conflict with the statutory duties of the state health officer. The amendment also removes the state health officer as the administrative officer of the state department of health based on merging the state department of health with the department of human services. The amendment also removes the requirement of the governor appointing at least three licensed physicians if a state health officer is not appointed. Finally, the amendment amends the state health officer's role based on merging the two agencies.

Page 137, lines 6 through 16, replaces state health officer with the executive director of the department of health and human services or designee regarding the appointment of members of the acute cardiovascular emergency medical system of care advisory committee.

Page 139, line 29, replaces director of the state department with the department of health and human services regarding the adoption of rules.

Page 152, lines 5 through 8, replaces the state health officer with the department of health and human services regarding the ability to enter into contracts.
