1. OHF funds are provided on a reimbursement basis. Costs incurred must be documented.

2. Projects can meet any one of the 4 OHF directives to be eligible: Access for Sportsman, Agricultural Stewardship, Habitat Development, Recreation. The more directives a project involves, the stronger the application.

3. In many cases, OHF funds and SWC funds are not for separate activities within the overall project. For example, the Cannonball River Fish Passage will receive both OHF funds and SWC funds for the dam construction. The total amount expended by OHF and SWC would not exceed actual costs incurred.
