

# **ND University System Facts**

North Dakota voters established the State Board of Higher Education (SBHE) in 1939 to govern the 11 publicly funded institutions of the North Dakota University System. Twelve other states and territories use a similar, consolidated governing Board structure (Source: Education Commission of the states).

The SBHE carries out its constitutional responsibilities through a comprehensive set of policies. The Chancellor serves as the NDUS' chief executive officer. The Chancellor and the system office staff support the SBHE in developing public policy for the NDUS, in advocating on its behalf, and fostering shared governance and leadership throughout the system.

The SBHE governs 11 institutions: five two-year colleges, four regional universities, and two research universities.



Dual credit enrollments have grown by 25% in the past five years and 97% of dual credit students received a passing grade in 2019/2020





## 2020-2021 Annual Budget

- On average, NDUS entities self-fund 75% of their budget and the State provides 25% from the general fund
- Most appropriated dollars come from the statutory higher education funding formula that rewards institutions for students' progress towards completion of their academic program

Major progress on cybersecurity, high performance computing, and unmanned aerial systems thanks to innovative work by researchers, and public/ private partnerships.

#### **Economic Impact**

Total NDUS economic impact in North Dakota was \$5.5 billion in FY2019.This includes direct expenditures by the NDUS and its students, as well as the resulting indirect business activity created.

Institutions generated \$2.82 non-general fund dollars for each dollar invested by the State in 2019. If secondary business activity were to be considered, the actual ROI is considerably higher.
