- **Information Technology Department** ([Request #2083](#)) - The request is to increase federal funds spending authority in the operating expenses line item by \$516,000 for a state digital equity planning grant program made available as a result of the federal Infrastructure Investment and Jobs Act (IIJA).
  - **Information Technology Department** ([Request #2084](#)) - The request is to increase special funds spending authority in the operating expenses line item by \$4.5 million from funding received from agencies requesting services from the department.
  - **Information Technology Department** ([Request #2085](#)) - The request is to increase federal funds spending authority in the operating expenses line item by \$5 million for a broadband equity, access, and deployment (BEAD) planning grant program made available as a result of IIJA.
  - **Department of Career and Technical Education** ([Request #2086](#)) - The request is to increase federal funds spending authority in the grants line item by \$640,000 from federal Carl D. Perkins grant funds.

- **Department of Commerce** ([Request #2093](#)) - The request is to increase federal funds spending authority by \$572,143 from funding available from the Small Business Credit Initiative Act, as amended by the American Rescue Plan Act.
- **Department of Health and Human Services** ([Request #2094](#)) - The request is to transfer \$500,000 of federal funds authority from the COVID-19 line item to the grants line item to provide a federal Ebola preparedness grant to Sanford Health of Fargo.
