- <u>Bill Draft No. 129</u> [25.0129.01000], which revises eligibility requirements for Teachers' Fund for Retirement (TFFR) benefits
- <u>Bill Draft No. 143</u> [25.0143.01000], which provides for a state employee compensation adjustment and transfer to TFFR for a cost-of-living adjustment
- <u>Bill Draft No. 40</u> [25.0040.01000], which expands participation in the public safety retirement plan to include correctional officers employed by a governmental unit
- <u>Bill Draft No. 134</u> [25.0134.01000], which revises the Public Employees Retirement System (PERS) definition of correctional officer
- <u>Bill Draft No. 68</u> [25.0068.01000], which provides for health benefit plans to include any amount paid by an enrollee, or on behalf of an enrollee, when calculating an enrollee's overall contribution to an out-of-pocket maximum or cost-sharing requirement for a prescription drug
- <u>Bill Draft No. 75</u> [25.0075.02000], which provides PERS health benefits coverage may not impose cost-sharing requirements for diagnostic or supplemental breast examination services
- **Bill Draft No. 84** [25.0084.01000], which provides for medical assistance coverage to include payment for applied behavioral analysis
