BILL DRAFT ACTUARIAL REPORTS AND COMMENTS

Committee consideration and receipt of <u>technical comments</u>, actuarial information, and <u>comments</u> by interested persons relating to bill drafts, over which the committee took jurisdiction, which affect, actuarially or otherwise, the retirement programs of state employees or employees of any political subdivision, and health and retiree health plans of state employees or employees of any political subdivision pursuant to Section 54-35-02.4:

- <u>Bill Draft No. 0041</u> [25.0041.01000], which revises the definition of correctional officer and expands eligibility for the public safety retirement plan to include dispatchers and emergency medical services personnel
- <u>Bill Draft No. 0045</u> [25.0045.01000], which expands eligibility for the public safety retirement plan to include correctional officers employed by a governmental unit, dispatchers, and medical services personnel, and limits application
- <u>Bill Draft No. 0118</u> [25.0118.01000], which <u>provides</u> for health benefit plans to include benefits for insulin drug and medical supplies for insulin dosing and administration
- <u>Bill Draft No. 0138</u> [25.0138.01000], which provides for step therapy protocol exceptions

• <u>Bill Draft No. 0142</u> [25.0142.01000], which <u>provides</u> the Public Employees Retirement System health benefits coverage for state employees and retirees must be compliant with the Patient Protection and Affordable Care Act
