

**FIRST ENGROSSMENT
with Senate Amendments
ENGROSSED HOUSE BILL NO. 1006**

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the North Dakota
2 aeronautics commission; and to provide an exemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and
7 other income, to the North Dakota aeronautics commission for the purpose of defraying the
8 expenses of the North Dakota aeronautics commission, for the biennium beginning July 1,
9 2023, and ending June 30, 2025, as follows:

20 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**
21 **SIXTY-NINTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding
22 items approved by the sixty-seventh legislative assembly for the 2021-23 biennium and the
23 2023-25 one-time funding items included in the appropriation in section 1 of this Act:

5 The 2023-25 biennium one-time funding amounts are not a part of the entity's base budget
6 for the 2025-27 biennium. The aeronautics commission shall report to the appropriation
7 committees of the sixty-ninth legislative assembly on the use of this one-time funding for the
8 biennium beginning July 1, 2023, and ending June 30, 2025.

9 **SECTION 3. ESTIMATED INCOME - AIRPORT INFRASTRUCTURE FUND - AIRPORT**

10 **GRANTS - EXEMPTION.** The estimated income line item in section 1 of this Act includes

11 \$20,000,000 from the airport infrastructure fund for the aeronautics commission to provide
12 grants to airports during the biennium beginning July 1, 2023, and ending June 30, 2025.

13 Section 54-44.1-11 does not apply to this funding, and any funds not spent by June 30, 2025,
14 must be continued into the biennium beginning July 1, 2025, and ending June 30, 2027, and
15 may be expended only for providing grants to airports.

16 **SECTION 4. EXEMPTION - FEDERAL STATE FISCAL RECOVERY FUND.** Section

17 54-44.1-11 does not apply to the appropriation in subsection 41 of section 1 of chapter 550 of
18 the 2021 Special Session Session Laws, and any unexpended funds from this appropriation

19 may be continued and used for the purpose of airport infrastructure grants during the biennium
20 beginning July 1, 2023, and ending June 30, 2025.
