BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying the expenses of the office of the governor, for the biennium beginning July 1, 2023, and ending June 30, 2025, as follows:

SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO

SIXTY-NINTH LEGISLATIVE ASSEMBLY. The following amounts reflect the one-time funding

- 1 items approved by the sixty-seventh legislative assembly for the 2021-23 biennium and the
- 2 2023-25 biennium one-time funding items included in the appropriation in section 1 of this Act:

The 2023-25 biennium one-time funding amounts are not a part of the entity's base budget for the 2025-27 biennium. The governor shall report to the appropriations committees of the sixty-ninth legislative assembly on the use of this one-time funding for the biennium beginning July 1, 2023, and ending June 30, 2025.

SECTION 3. ADDITIONAL INCOME - APPROPRIATION - GOVERNOR'S OFFICE -

BUDGET SECTION REPORT. Subject to the limitations of this section, in addition to the amounts appropriated in section 1 of this Act, there is appropriated to the governor's office, any additional income from other funds, excluding federal funds, which may become available to the governor's office, for the period beginning July 1, 2023, and ending June 30, 2025. Any other funds received under this section must be used for the specific purpose intended for the funds or transferred to the appropriate state agency or institution. Upon the receipt of other funds under this section, the governor's office shall provide a report to the budget section regarding the source, amount, and purpose of the funds received. Federal funds which may become available to the governor's office may be accepted by the governor's office. Federal funds accepted by the governor's office may not be spent until authorization is received from the legislative assembly or from the emergency commission and budget section under chapter 54-16.

SECTION 4. GOVERNOR'S SALARY - EXEMPTION. The governor's salary line item in section 1 of this Act includes the sum of \$310,621 for the salary of the governor for the biennium beginning July 1, 2023, and ending June 30, 2025. If the governor chooses not to accept the salary or any portion of the salary pursuant to section 54-07-04, section 54-07-04 does not apply to the portion of the salary not accepted. Notwithstanding section 54-16-04, the office of management and budget may transfer appropriation authority from the governor's salary line item to other line items in section 1 of this Act.

SECTION 5. AMENDMENT. Section 54-07-04 of the North Dakota Century Code is 2 amended and reenacted as follows: 3 54-07-04. Salary of governor. 4 The annual salary of the governor is one hundred forty thousand eight hundred 5 twenty-ninefifty-two thousand two hundred sixty-five dollars through June 30, 20222024, and 6 one hundred forty-three thousand six hundred forty-sixfifty-eight thousand three hundred fifty-six 7 dollars thereafter. 8 SECTION 6. AMENDMENT. Section 54-08-03 of the North Dakota Century Code is 9 amended and reenacted as follows: 10 54-08-03. Salary of lieutenant governor. 11 The annual salary of the lieutenant governor is one hundred nine thousand five hundred-12 thirty-sixthirty thousand dollars through June 30, 20222024, and one hundred eleven thousand 13 seven hundred twenty-seventhirty-five thousand two hundred dollars thereafter.
