1 A BILL for an Act to amend and reenact subsection 2 of section 39-06.1-06 of the North Dakota
2 Century Code, relating to the fee for failure to adhere to right of way offenses; and to provide a
3 penalty.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Subsection 2 of section 39-06.1-06 of the North Dakota
6 Century Code is amended and reenacted as follows:

7 2. For a moving violation as defined in section 39-06.1-09, a fee of twenty dollars, except
8 for:

- 9 a. A violation of section 39-10-26, 39-10-26.2, 39-10-41, or 39-10-42, a fee of fifty
10 dollars.
- 11 b. A violation of section 39-10-05 involving failure to yield to a pedestrian or
12 subsection 1 of section 39-10-28, a fee of fifty dollars.
- 13 c. A violation of section 39-21-41.2, a fee of twenty-five dollars.
- 14 d. A violation of subsection 1 of section 39-12-02, section 39-08-23, or section
15 39-08-25, a fee of one hundred dollars.
- 16 e. A violation of subdivision d of subsection 1 of section 39-12-04, a fee of one
17 hundred dollars.
- 18 f. A violation of subsection 6 of section 39-04-37, a fee of one hundred dollars.
- 19 g. A violation of subsection 2 of section 39-10-21.1, a fee of two hundred fifty
20 dollars.
- 21 h. A violation of section 39-10-59, a fee of five hundred dollars.
- 22 i. A violation of section 39-09-01, a fee of thirty dollars.
- 23 j. A violation of section 39-09-01.1, a fee of thirty dollars.
- 24 k. A violation of section 39-10-46 or 39-10-46.1, a fee of one hundred dollars.

- 1 l. A violation of subsection 1 of section 39-08-20, one hundred fifty dollars for a first
2 violation and three hundred dollars for a second or subsequent violation in three
3 years.
- 4 m. A violation of section 39-10-04, 39-10-05 not involving failure to yield to a
5 pedestrian, 39-10-07, 39-10-22, 39-10-22.1, 39-10-23, 39-10-24 or, 39-10-25,
6 39-10-37, 39-10-44, 39-10-45, 39-10-68, or 39-10-72, a fee of forty dollars.
- 7 n. A violation of section 39-10-50.1, a fee of fifty dollars.
- 8 o. A violation of section 39-19-03, a fee of fifty dollars.
