with House Amendments

1 A BILL for an Act to amend and reenact section 23-12-20 of the North Dakota Century Code,  
2 relating to vaccination and infection information.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 23-12-20 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **23-12-20. COVID-19 vaccination and infection information. (~~Repealed effective August-~~**  
7 **~~4, 2023~~)**

8 1. Neither a state government entity nor any of its political subdivisions, agents, or  
9 assigns may:

10 a. Require documentation, whether physical or electronic, for the purpose of  
11 certifying or otherwise communicating the following before providing access to  
12 property, funds, or services:

13 (1) An individual's COVID-19 vaccination status or vaccination status for a  
14 vaccine that is under emergency use authorization from the federal food and  
15 drug administration;

16 (2) The presence of COVID-19 pathogens, antigens, or antibodies; or

17 (3) An individual's COVID-19 post-transmission recovery status;

18 b. Otherwise publish or share an individual's COVID-19 vaccination record or similar  
19 health information, except as specifically authorized by the individual or otherwise  
20 authorized by statute; or

21 c. Require a private business to obtain documentation, whether physical or  
22 electronic, for purposes of certifying or otherwise communicating the following  
23 before employment or providing access to property, funds, or services based on:

- 1                   (1) An individual's COVID-19 vaccination status or vaccination status for a  
2                   vaccine that is under emergency use authorization from the federal food and  
3                   drug administration;
- 4                   (2) The presence of COVID-19 pathogens, antigens, or antibodies; or
- 5                   (3) An individual's COVID-19 post-transmission recovery status.
- 6                   2. Subsection 1 does not apply to the department of corrections and rehabilitation, a  
7                   correctional facility as defined under section 12-44.1-01, the state hospital, or a public  
8                   health unit.
- 9                   3. A private business located in this state or doing business in this state may not require  
10                  a patron, client, or customer in this state to provide any documentation certifying  
11                  COVID-19 vaccination or vaccination authorized by the federal food and drug  
12                  administration under emergency use authorization, the presence of COVID-19  
13                  pathogens, antigens, or antibodies, or COVID-19 post-transmission recovery to gain  
14                  access to, entry upon, or services from the business. This subsection does not apply  
15                  to a developmental disability residential facility or a health care provider, including a  
16                  long-term care provider, basic care provider, and assisted living provider. As used in  
17                  this subsection, a private business does not include a nonprofit entity that does not sell  
18                  a product or a service.
- 19                  4. This section may not be construed to interfere with an individual's rights to access that  
20                  individual's own personal health information or with a person's right to access personal  
21                  health information of others which the person otherwise has a right to access.
- 22                  5. Subsection 1 is not applicable to the state board of higher education, the university  
23                  system, or institutions under the control of the state board of higher education to the  
24                  extent the entity has adopted policies and procedures governing the type of  
25                  documentation required, the circumstances under which such documentation may be  
26                  shared, and exemptions from providing such documentation.
- 27                  6. This section is not applicable during a public health disaster or emergency declared in  
28                  accordance with chapter 37-17.1.
- 29                  7. As used in this section, the term "COVID-19" means severe acute respiratory  
30                  syndrome coronavirus 2 identified as SARS-CoV-2 and any mutation or viral  
31                  fragments of SARS-CoV-2.
